

**L.N. 186 of 2004****TRADE DESCRIPTIONS (COUNTRY OF MANUFACTURE)  
(TEXTILE MADE-UP ARTICLES) ORDER**

(Made under section 2(2)(b)(ii) of the Trade Descriptions Ordinance  
(Cap. 362))

**1. Commencement**

This Order shall come into operation on 1 January 2005.

**2. Interpretation**

In this Order—

“HS code” (協調制度編號) means the code described as item code in the Hong Kong Imports and Exports Classification List (Harmonized System) issued by the Commissioner of Customs and Excise by notice G.N.(S.) 139 of 2001 published in the Gazette, as amended by notices G.N.(S.) 137 of 2002 and G.N.(S.) 102 of 2003 published in the Gazette;

“textile made-up article” (紡織製成品) means—

- (a) any article which under the Hong Kong Imports and Exports Classification List (Harmonized System) has been assigned an HS code the first 6 digits of which are specified in the Schedule; and
- (b) any baby napkin which under the Hong Kong Imports and Exports Classification List (Harmonized System) has been assigned an HS code the first 6 digits of which is 620920.

**3. Non-application of Order**

This Order does not apply to any textile made-up article to which the Trade Descriptions (Place of Manufacture) (Textile Made-up Articles) Notice (L.N. 187 of 2004) applies.

**4. Country of manufacture or production**

The country in which all the fabrics used in the manufacture of any textile made-up article to which this Order applies—

- (a) were manufactured or produced; or
- (b) were cut and the cut-pieces were sewn into such a textile made-up article,

is to be regarded, for the purposes of the Ordinance, as the country in which the textile made-up article has been manufactured or produced.

**Explanatory Note**

If a certain manufacturing process of any textile made-up article takes place in a certain country, this Order specifies such country is the country in which the textile made-up article is to be regarded, for the purposes of the Trade Descriptions Ordinance (Cap. 362), as having been manufactured or produced.

2. The textile made-up articles to which the Order applies are specified in the Schedule by reference to the HS code to which the articles belong. Such articles include shawls, scarves, ties, bow ties, bags, curtains, pillow covers, bed sheets, table linen, etc. The HS codes are contained in the Hong Kong Imports and Exports Classification List (Harmonized System).
3. The Order does not apply to any textile made-up article to which the Trade Descriptions (Place of Manufacture) (Textile Made-up Articles) Notice (L.N. 187 of 2004) applies.
