 - (b) the electoral arrangements to deal with the situation illustrated in LC Paper No. CB(2)1526/04-05(02), particularly in relation to the finality issue and the re-constitution of the Election Committee;
 - (c) in the event that a new CE was not elected before 1 July 2007, the arrangements (including any contractual arrangements) in relation to the appointment of acting CE, principal officials and Executive Council Members until a new CE was elected and the legal basis for such arrangements;
 - (d) the commencement date of the term of office of the National Committee of the Chinese People's Political Consultative Conference;
 - (e) whether section 11(3) was adequate to provide a legal basis for fixing a new polling date in the event that the court had determined in an election petition that a candidate was not duly elected at an election under section 37; and
 - (f) in the case of a by-election to fill a vacancy in the office of CE that would arise under section 4(b) or (c), the basis for providing 120 days for the first election and only 42 days for the second election if the first election failed.

(*Post-meeting note*: The Administration responses were issued to members vide LC Paper Nos. CB(2)1585/05-06(01) and CB(2)1629/05-06 (01) on 29 and 31 March 2006 respectively.)
