I. Meeting with the Administration

- 2. The Bills Committee requested the Administration
 - (a) to illustrate, using past cases, the type of information that would be provided to a panel judge when an application was made for judicial authorisation of interception of communications or surveillance;
 - (b) to reconsider the feasibility of providing the number of cases of interception of communications/surveillance, broken down by serious crime and public security;
 - (c) to consider providing in the Bill that the Commissioner on Interception of Communications and Surveillance (the Commissioner) should be appointed by the Chief Executive with the endorsement of the Legislative Council;
 - (d) to consider establishing a mechanism to keep the Legislative Council informed of any disagreement between the Commissioner and the Chief Executive on matters to be excluded from the copy of the Commissioner's annual report to be laid on the table of the Legislative Council under clause 47(5) of the Bill;
 - (e) to consider establishing a committee to review the work of the Commissioner; and
 - (f) to consider establishing a mechanism for the keeping and destruction of intelligence derived from interception of communications and covert surveillance activities, and requiring an application for the keeping of such intelligence to be submitted to a panel judge.
