2. The Bills Committee requested the Administration –

Definition of "data surveillance device"

(a) to consider amending the phrase "device or program" in the definition of "data surveillance device" along the lines of device, program or any other means;

Definition of "information system"

(b) to provide the definitions of "information system" in other local legislation and consider amending the definition of "information system", having regard to such definitions;

Definition of "listening device"

(c) to consider improving the drafting of the Chinese version of the definition of "listening device";

Definition of "maintain"

(d) to consider deleting, qualifying or substituting the term "relocate" in the definition of "maintain";

Definition of "optical surveillance device"

(e) to consider including optical surveillance device in the Administration's paper or briefing, if any, on the data surveillance devices used by law enforcement agencies of Hong Kong;

Definition of "postal interception" and "postal service"

- (f) to explain whether postal interception covered opening a postal article for the purpose of forensic examination of the contents, obtaining the name and address of the sender or changing the contents of the article without reading the contents; and
- (g) to consider providing a clearer definition for "postal service".

3. The Administration would move CSAs to –

(a) amend "the communication" in paragraph (a) of the definition of "interception" along the lines of "that communication"; and

(b) amend "in respect of communications" in paragraph (b) of the definition of "interception" along the lines of "in respect of any communication".
