I. Meeting with the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

2. The Bills Committee requested the Administration –

<u>Definition of "premises"</u>

(a) to explain whether an authorisation for surveillance would cover authorisation for the use of surveillance devices outside the territory of Hong Kong and the use of such devices within Hong Kong on targets outside Hong Kong;

Definition of "public place"

(b) to consider amending "to the extent that they are intended" in the definition of "public place" along the lines of "used or intended for use" or "for the purpose of";

Definition of "serious crime"

(c) to provide a list of offences with a maximum penalty of over three years and below seven years of imprisonment;

Definition of "surveillance device"

- (d) consider providing in the Bill that a regulation made under clause 62 in respect of the inclusion of new types of surveillance devices was subject to positive vetting by the Legislative Council;
- (e) to consider whether sub-clause (c) in the definition of "surveillance device" should be set out in a separate provision in the Bill;
- (f) to consider excluding surveillance devices involving the implantation or swallowing of such devices into a human body from the Bill;

Definition of "transmitted"

(g) to consider whether there was a need for the definition of "transmitted";

Definition of "Type 2 surveillance"

(h) to consider substituting "to the extent that" with "which" in the definition of "Type 2 surveillance" and amending sub-clause (a)(i) in the same definition along the lines of -

"(i) who -

(A) is a person privy to the conversation or the activity; or

- (B) is a person who is expected to be able to hear the conversation or to see the activity; or";
- (i) to consider prohibiting the use of optical surveillance device on targets in bathrooms or changing rooms;

Clause 2(2)

(j) to consider improving the drafting of clause 2(2) in respect of "in relation to any activity";

Clause 2(4)

- (k) to explain the difference between the covert surveillance of electronic mails and their interception;
- (l) to consider the need for clause 2(4)(b); and

<u>Others</u>

- (m) to advise whether the more stringent authorisation would be required when more than one type of authorisation was required;
- 3. The Bills Committee requested Senior Assistant Legal Adviser 1 to find out if there were examples in local legislation where the drafting was similar to that in sub-clause (c) of the definition of "surveillance device".

- 4. The Bills Committee noted that the next meeting had been scheduled for Friday, 2 June 2006 at 8:30 am to continue discussion with the Administration.
