#### I. Meeting with the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

- 2. The Bills Committee requested the Administration -
  - (a) to consider setting out in the code of practice the safeguards of the mechanism for dealing with property intercepted in a postal interception;
  - (b) to consider adding ", whether physically or electronically," after "premises" in paragraph (b)(i) of the definition of "Type 2 surveillance";
  - (c) to provide the Committee Stage amendments to clause 65, having regard to the judgment delivered by the Court of Final Appeal (CFA) in *Koo Sze Yiu and Leung Kwok-hung v. Chief Executive of the Hong Kong Special Administrative Region* on 12 July 2006;
  - (d) to consider amending the proposed section 33(1) of the Telecommunications Ordinance (TO) (Cap. 106) along the lines of "For the purpose of execution of the prescribed authorisation, the Chief Executive may order the installation, provision or make available the facilities reasonably required for the execution"; and
  - (e) to provide further information, if any, on the provisions in section 33 of TO which had not been ruled unconstitutional by CFA.
- 3. The Administration advised that the requirement of setting out in an Affidavit the devices to be used and period of operation of the devices would be spelt out in the code of practice.

- 4. The Bills Committee noted that the next meeting had been scheduled for the same afternoon to continue discussing Members' draft Committee Stage amendments.
