Action

I. Discussion on outstanding issues

[LC Paper Nos. CB(2)2343/05-06(01), CB(2)2373/05-06(01) - (03)]

The Bills Committee deliberated (Index of proceedings attached in **Annex**).

Committee Stage amendments

- 2. <u>Mr Andrew CHENG</u> briefed members on the draft Committee Stage amendments (CSAs) as detailed in his paper [LC Paper No. CB(2)2373/05-06(02)]. <u>Mr CHENG</u> intended to propose the following amendments to the Bill –
- (a) to add a new section 6GB(4)(g)(iii) to require that in conducting any advertising or promotional activities, an authorised horse race betting conductor should display or carry notices containing a warning of the seriousness of problems caused by excessive gambling and providing

- information on the services and facilities available to problem and pathological gamblers;
- (b) to add a new section 6GB(4)(h) to require that a formula or rule for determining the rebates payable be specified in the licence for the conduct of authorised horse race betting;
- (c) to add a new section 6GB(8) to empower the Legislative Council (LegCo) to amend, by resolution, the licensing conditions for horse race betting under section 6GB(4); and
- (d) to add a new section 6I(7) to empower LegCo to amend, by resolution, the licensing conditions for the conduct of authorised football betting.

Proposed new section 6GB(4)(g)(iii)

3. <u>Miss CHAN Yuen-han</u> expressed support for the proposed CSA to add a new section 6GB(4)(g)(iii). <u>Mr WONG Ting-kwong</u> considered that tackling gambling-related problems was an issue which was broader than the scope of the Bill, and display of warning notices against excessive gambling should not be imposed solely on HKJC. <u>Mr Abraham SHEK</u> said that he did not support the proposed CSA. <u>Mr SHEK</u> considered that HKJC should be advised and not legally required to display warning notices.

Proposed new section 6GB(4)(h)

4. Mr Tommy CHEUNG, Mr Jeffrey LAM and Mr Abraham SHEK said that they did not support the proposed CSA to add a new section 6GB(4)(h). They considered that providing rebates to high-value bettors would not encourage gambling, and HKJC should be given flexibility in determinating high-value bets and the percentage of rebates to such bets, in order to compete with the illegal bookmakers.

Proposed new section 6GB(8)

5. Mr Abraham SHEK, Mr Tommy CHEUNG, Mr Jeffrey LAM and Mr WONG Ting-kwong had indicated that they did not support the proposed CSAs to add a new section 6GB(8). These members were of the view that the proposed CSAs would create uncertainty for the licencee on the conduct of authorised betting. Mr WONG Ting-kwong added that the licensing authority for the conduct of authorised betting should be the Executive Authorities, and not the LegCo.

Proposed new section 6I(7)

- 6. <u>Assistant Legal Adviser</u> gave a preliminary view that subject to the President's ruling, the proposed CSA to add a new section 6I(7) might be outside the scope of the Bill. He was requested to put his advice in writing for the Bills Committee's reference.
- 7. <u>Members</u> also noted the revised Chinese version of the CSAs proposed by the Administration. <u>Members</u> had not raised objection.

Follow-up actions required

- 8. The Bills Committee requested the Administration to
 - (a) provide written information on the principles in handling requests for a replaced race meeting due to the cancellation of certain races in a race meeting, or explain how such requests would be handled at the resumption of the Second Reading debate on the Bill;
 - (b) convey to the Security Bureau the views of some members on the need to review the Organized and Serious Crimes Ordinance to facilitate confiscation of money/assets in connection with illegal bookmaking activities;
 - (c) advise the number of convicted bookmaking cases involving the Internet;
 - (d) clarify whether advertising football betting was permissible in Cable Channels 61 and 63;
 - (e) comment on the Committee Stage amendments proposed by Hon Andrew CHENG; and
 - (f) confirm the tentative date on which the Bill, if enacted, would come into operation.

Resumption of Second Reading debate

9. <u>The Bills Committee</u> supported the Administration's proposal to resume the Second Reading debate on the Bill at the Council meeting on 12 July 2006. <u>Members</u> agreed that the Bills Committee would report its deliberations on the Bill to the House Committee on 23 June 2006. <u>The Chairman</u> reminded members that the deadline for submission of notice to move CSAs to the Bill was 3 July 2006.
