I. Confirmation of minutes of meeting

(LC Paper No. CB(2)2696/05-06 – Minutes of meeting on 1 June 2006)

The minutes of the meeting held on 1 June 2006 were confirmed.

II. Meeting with the Administration

(LC Paper No. CB(2)2695/05-06(01) – Paper provided by the Administration in response to issues raised at the meeting on 1 June 2006

LC Paper No. CB(3)532/05-06 – The Bill)

- 2. The Bills Committee deliberated (index of proceedings attached at **Annex**).
- 3. The Administration was requested to consider introducing amendments to the Bill as follows
 - (a) <u>clause 2</u> members pointed out that the term "specified person" was defined in clause 2 and repeated in the relevant provisions in the Bill. For the sake of simplicity, the Administration was requested to consider deleting the definition from clause 2, and replacing the definition in the relevant provisions of the Bill with words "Chinese national and a Hong Kong permanent resident" taking into account the proposed extension of extra-territoriality to cover stateless persons who were Hong Kong permanent residents; and
 - (b) <u>clauses 4 and 5</u> given the higher penalty prescribed for the offence of threat under the Bill, members considered that the "intent" to commit crimes against a United Nations and associated personnel, or the "knowledge" that the crime was targeted at a United Nations and associated personnel should be included as an element of the offence of threat. The Administration was requested to consider amending clause 4 or 5 to such an effect, and introducing related consequential amendments.
- 4. The Administration advised that Committee Stage amendments (CSAs) would be proposed to extend extra-territoriality to cover stateless persons who were Hong Kong permanent residents. As a result of this CSA, consequential amendments to relevant provisions and the long title of the Bill would be required.
- 5. The Bills Committee completed clause-by-clause examination of the Bill and would scrutinize draft CSAs proposed by the Administration, the draft International Organizations (Privileges and Immunities) (United Nations and Associated Personnel)

Order, and the draft Fugitive Offenders (Safety of United Nations and Associated Personnel) Order at the next meeting.

- 6. The Clerk would liaise with the Administration on the date of the next meeting, pending the information to be provided by the Administration to the Bills Committee.
- 7. The meeting ended at 5:10 pm.
