## Annex A

## Applications for One-off Grants by Local Workers of Live Poultry Farming/Wholesale/Transport Trade

Under the Voluntary Surrender Scheme for Poultry Farmers, Wholesalers and Transporters (VSS), no dedicated retraining schemes has been arranged for workers from these trades when they are rendered unemployed and apply for one-off grants under the VSS. Instead, they are free to enroll in Labour Department retraining courses of their choice.

For privacy reasons, the Agriculture, Fisheries and Conversation Department (AFCD) has no authority under the VSS to formally seek information on the employment status of the recipients of the one-off grants, nor to enquire about their status as far as the Comprehensive Social Security Allowance (CSSA) is concerned.

# Applications for One-off Grants by Local Workers of Live Poultry Retail Trade

As at 30.4.2006, FEHD has received 162 applications for one-off grant for retail poultry workers under the Voluntary Surrender Scheme (VSS), of which 143 have been approved, 11 rejected and 8 are being processed. Among the 162 applicants, 43 had completed the retraining course provided by the Employees' Retraining Board as arranged by the Department at the early stage of the VSS. Concurrent with the approval on revision of the one-off grant from \$10,000 to \$18,000 by the Finance Committee of the LegCo in July 2005, the retraining course ceased to be provided.

FEHD has not maintained data on whether these workers have secured another job or are relying on the Comprehensive Social Security Allowance (CSSA) for privacy reasons. The Department also has no authority to demand for the information. In the circumstance, the Department cannot provide information on the number of workers who

- (i) have joined the retraining programme organized by the Employees' Retraining Board and are able to secure alternative employment; and
- (ii) remain unemployed and have to rely on the CSSA.
