#### I. Election of Chairman

Hon James TO was elected Chairman of the Subcommittee.

2. <u>The Subcommittee</u> accepted Hon LAU Kong-wah's application for joining the Subcommittee after the deadline.

#### II. Meeting with the Administration

[LC Paper Nos. CB(2)1364/05-06(01) & (02)]

- 3. The Subcommittee deliberated (index of proceedings attached at **Annex**).
- 4. <u>The Subcommittee</u> examined the Mutual Legal Assistance (MLA) in Criminal Matters (Poland) Order and the Mutual Legal Assistance in Criminal Matters (Irsael) Order, by making reference to the article-by-article comparison of the two Orders with the Model Agreement provided by the Administration [LC Paper Nos. CB(2)1364/05-06(01)&(02)].
- 5. In view of the concerns raised by members, the Administration undertook to –

#### Poland Order

- (a) consider whether Article 7(3) in the Agreement in relation to the use or disclosure of information exculpatory to the defendant in a criminal prosecution should be made a standard provision in future agreements to be negotiated with other jurisdictions;
- (b) provide information on the safeguards to protect the legal rights of a person transferred under Article 11(2);

#### Israel Order

(c) in relation to Article 1(1), explain whether the reference to the scope of assistance for "prevention of offences" is consistent with the ambit of the Mutual Legal Assistance in Criminal Matters Ordinance (Cap. 525);

- (d) in relation to Article 4(1), consider undertaking that Hong Kong would not request for assistance if according to the laws of Hong Kong, assistance should be refused where the request related to the grounds set out in that Article;
- (e) in relation to Article 4(1)(g), advise whether it was a mandatory provision under Cap. 525 to deny assistance on grounds of confidentiality; and
- (f) in relation to Article 7(4), provide information on the criteria for awarding compensation under the laws of Israel.
- 6. <u>The Subcommittee</u> completed scrutiny of the two Orders. <u>The Chairman</u> said that the information to be provided by the Administration in paragraph 5 above would be circulated to members for consideration. If members did not raise further queries on the two Orders, no further meeting of the Subcommittee would be held. The Subcommittee would then provide a report to the House Committee.
- 7. There being no other business, the meeting ended at 12:20 pm.
