Action

I. Election of Chairman

Mr KWONG Chi-kin was elected Chairman of the Subcommittee.

II. Meeting with the Administration

[LegCo Brief: SEC 9/6/11, LC Paper Nos. LS72/05-06, CB(2)2124/04-05(01), CB(2)2285/05-06(01) & (02)]

- 2. The Subcommittee deliberated (index of proceedings attached at **Annex**).
- 3. <u>Principal Assistant Secretary (Security) A</u> (PAS(S)A) explained that the fee proposals were based on the policy of full cost recovery. For the various security company licences (licences), the downward fee adjustments were attributable to the decrease in costs. For example, the removal of the Security Companies Inspection Unit from commercial premises to the Police Headquarters in August 2004 had resulted in lower office accommodation cost.
- 4. On the increase in the cost for the issue and renewal of the security personnel permits (permits), <u>PAS(S)A</u> informed the Subcommittee that the main increase was in staff costs. She said that the Independent Commission Against Corruption (ICAC) had conducted a review in 2000 on the issue of permits and made a series of recommendations for the purpose of corruption prevention. The recommendations included assigning more senior police and clerical officers to conduct supervisory and random checks in respect of applications submitted by applicants who had record of criminal conviction(s), and before permits were to be issued. The Police Licensing Office (PLO) had adopted the recommendations and had increased the number of higher-ranked clerical officers and the number of supervisory checks performed, which had resulted in an increase in staff costs. She added that PLO had already implemented efficiency measures and streamlined procedures to maintain costs at a reasonable level.
- 5. <u>Members</u> present objected to the proposed increase of permit fees mainly on the following grounds –

- the measures taken to tighten up the vetting process seemed to be (a) unnecessary because it was questionable whether anyone would resort to bribery in order to get such a low-pay job as that of security guards;
- (b) while the Administration said that the job of security guards was very important and considered it necessary to conduct stringent vetting of applications for the permits, the low salary level of security guards had failed to reflect such high importance attached to the job;
- (c) it would be unfair to require the security personnel who were low-income employees to bear the increase in cost and to increase their financial burden.

- 6. After discussion, PAS(S)A said that the Administration would carefully consider members' views and examine whether the increase of permit fees should The Chairman requested the Administration to provide a written reply for circulation to members. He said that if the Administration decided to proceed with the proposed increase, the Administration would need to provide a detailed cost analysis for the Subcommittee to consider whether there was room for cost compression at a future meeting.
- 7. Members agreed that if the Administration decided not to increase the permit fees, and subject to members' confirmation, it would not be necessary for the Subcommittee to conduct further discussion on the Amendment Regulation. Members further agreed that the Chairman would move a motion at the Council meeting on 21 June 2006 to extend the scrutiny period of the Amendment Regulation Members noted that if the scrutiny period was extended, the to 12 July 2006. deadline for giving notice to amend the Amendment Regulation would be 5 July 2006.
- 8. There being no other business, the meeting ended at 3:00 pm.
