Findings of a consultancy study on the local auto-fuel retail market

At the meeting of the Legislative Council Panel on Economic Services held on 24 April 2006 where the above subject was discussed, Members requested that the Administration -

- (a) provide information on the historic land values for all petrol filling station (PFS) sites as the background to the cost estimates in the consultant's net margin analysis;
- (b) convey Members' views on the need to reduce the excise duties on auto-fuel in order to maintain the competitive edge of Hong Kong and to relieve the burden of the affected economic sectors to the Financial Secretary, for consideration; and
- (c) take into consideration Member's suggestion of providing more sites in the urban area to increase the supply of fuel storage facilities to enhance competition in the market.

Also, at the request of the Hon Tam Heung-man, the consultants agreed to provide details on the references in the study to overseas practices for Member's information.

Historical Land Values of PFS Sites

I attach at **Annex A** a chart showing the average land premiums paid for PFS sites from 1986 to 2005, and a list of the sites involved. It should be noted that the chart only captures information on sites sold for the purpose since 1986. Sites sold before 1986, sites where the leases have been renewed and sites converted from other private lots are not included.

In the course of their study, the consultants also received information from some of the oil companies on historical land costs. However, under the confidentiality agreements signed with these companies, the consultants may not disclose this information.

As the consultants explained at the Panel meeting, the purpose of the margin analysis was to help assess the degree of competition in the local auto-fuel retail market. In this context, the consultants used *recent* land prices to help determine the likely profitability of a "marginal" PFS, i.e., a PFS operated by any new entrant to the market. Whilst historically low land costs may help raise profitability for incumbent PFS operators, they are not relevant when assessing the current level of competition in the auto-fuel retail market. Further, the incumbents will also face these costs as PFS sites come up for renewal. Recent land prices were also used in assessing the margins of PFS in other cities, in order to provide a common basis for comparison.

Members' Views on the Need to Reduce Fuel Duty

We have conveyed Members' views on the need to reduce fuel duty to the Financial Services and the Treasury Bureau (FSTB) for consideration.

Providing Sites in the Urban Area for More Fuel Storage Facilities

We will continue to work with the Planning Department and the Lands Department to identify suitable sites for PFS, with a view to increasing the supply of fuel storage facilities and enhancing competition in the auto-fuel market.


