## LegCo Panel on Food Safety and Environmental Hygiene

### **Proposed Demerit Points System for Licensed Food Premises**

At the meeting of the LegCo Panel on Food Safety and Environmental Hygiene held on 6 April 2006, the Administration was asked to provide –

- (a) statistics on successful and unsuccessful prosecutions which the Food and Environmental Hygiene Department (FEHD) made against licensed food premises and the penalty awarded in the successful cases in the past five years; and
- (b) information on the number of food poisoning cases in Asian countries and the United States of America (USA), and the extent of such problems as compared to Hong Kong.
- 2. The statistics on successful and unsuccessful prosecutions initiated by the FEHD against licensed food premises for offences relating to the Demerit Points System and the penalty awarded in the last five years (i.e. from 2006 to 2010) are at **Annex I**.

3. The statistics on food poisoning cases in Hong Kong, Singapore, Japan and the USA from 2006 to 2010 are at Annex II. We do not have the statistics on food poisoning cases in other Asian countries, such as Korea, Malaysia, Philippines and Thailand. As the demographic characteristics, eating habits, licensing regime of food premises and notification system for food poisoning cases are different in different places, comparing the extent of food poisoning in Hong Kong with other countries would not be appropriate.
