# **Legislative Council Panel on Public Service**

### **Deletion of Obsolete Ranks**

## **Purpose**

This paper provides information on the proposed deletion of 31 obsolete ranks in the civil service. We will seek the endorsement of the Establishment Subcommittee and the approval of the Finance Committee on 14 June 2006 and 7 July 2006 respectively.

#### **Deletion of obsolete ranks**

- 2. It is a normal practice to delete ranks that are obsolete. We propose that 31 obsolete ranks as set out in the Annex be deleted. All the posts in these ranks are no longer required and have been deleted either by the Finance Committee or by Controlling Officers under delegated powers as appropriate. There is no intention to create new posts in the obsolete ranks.
- 3. There are no financial implications as there are at present no posts in the ranks proposed for deletion.
