LEGISLATIVE COUNCIL BRIEF

APPLICATION FOR NEW IDENTITY CARDS (PERSONS BORN IN OR BEFORE 1942, IN 1990 to 1992 OR 1997 TO 2003) ORDER

INTRODUCTION

The Application for New Identity Cards (Persons Born in or before 1942, in 1990 to 1992 or 1997 to 2003) Order ("the new Order"), made under section 7B(1) of the Registration of Persons ("ROP") Ordinance, Cap.177, aims to direct persons born in 1942 or before, 1990 to 1992 or 1997 to 2003 to apply for new identity ("ID") cards within specified periods at smart identity card centres during the sixth cycle of the replacement exercise. A copy of the new Order is at **Annex A**.

BACKGROUND

- 2. Under section 7B(1) of the ROP Ordinance, Cap.177, the Secretary for Security had made the Registration of Persons (Application for New Identity Cards) Order (Cap. 177 sub. leg. E) ("the ROP Order") and subsequent orders to provide for arrangements for the first five cycles and special phases of the new identity card replacement exercise covering, among others, persons born in 1943 to 1985. The relevant Orders are listed at **Annex B**.
- 3. To prepare for the sixth, or the last cycle of the exercise, the Secretary for Security has made the new Order to direct Hong Kong residents born in or before 1942, in 1990 to 1992 or 1997 to 2003 who hold valid identity cards to be replaced to apply for new ID cards within specified periods during the sixth cycle, which will commence on 10 July 2006 and end on 31 March 2007. For those residents who are not in Hong Kong during the specified periods, they can apply for their ID cards within 30 days of their return to Hong Kong.

THE NEW ORDER

4. **Section 1** of the new Order provides for its commencement date. **Section 2** amends Schedule 2 to the ROP Order by adding details of application periods for holders of valid ID cards to be replaced born in or before 1942, in 1990 to 1992 or 1997 to 2003.

PUBLIC CONSULTATION

6. The public and Members of the Legislative Council were informed of the launch of the replacement exercise and its progress since mid-2003 through progress reports and Legislative Council Briefs.

IMPLICATIONS OF THE PROPOSAL

- 7. The new Order is in conformity with the Basic Law, including the provisions concerning human rights.
- 8. The new Order will not affect the current binding effect of the ROP Ordinance (Cap. 177) and the ROP Regulations (Cap. 177 sub. leg. A) made thereunder.

PUBLICITY

9. Information on the replacement exercise will continue to be disseminated through posters, leaflets, short videos, press advertisements, Announcement of Public Interest on radio and television, and the telephone enquiry system and homepages of the

Immigration Department. The Hong Kong Economic and Trade Offices overseas and in Guangzhou and the Beijing Office will disseminate the above information to Hong Kong residents living outside Hong Kong.

"1983, 1984 or 1985 From 29 May 2006 to 8 July 2006".

Explanatory Note

This Order amends Schedule 2 to the Registration of Persons (Application for New Identity Cards) Order (Cap. 177 sub. leg. E). By virtue of the amendments and operation of section 3(3) of that Order, holders of valid identity cards who are born in the specified years shall apply for new identity cards with embodied chips in the specified periods. Failure to do so without reasonable excuse is a contravention of section 7B(1) of the Registration of Persons Ordinance (Cap. 177).
