**DUMPING AT SEA (FEES ADJUSTMENT) REGULATION 2005** 

#### INTRODUCTION

On 13 October 2005, the Secretary for the Environment, Transport and Works, after consultation with the Advisory Council on the Environment, has made the Regulations/Amendment Regulations at Annexes A to F in accordance with the Ordinances listed in the table below to revise the fees payable under their corresponding Regulations.

- 2. At the meeting of the Executive Council on 18 October 2005, the Council ADVISED and the Chief Executive ORDERED that, under section 46 of the Water Pollution Control Ordinance, the Water Pollution Control (General) (Amendment) Regulation 2005, at Annex G, should be made. This will revise the fees payable under the Water Pollution Control (General) Regulations.
- 3. On 13 October 2005, the Director of Environmental Protection has made the Dumping at Sea (Fees Adjustment) Regulation 2005, at Annex H, under section 4 and section 32 of the Dumping at Sea Ordinance (Cap. 466) to revise the fees payable under the Dumping at Sea (Fees) Regulation.

#### **BACKGROUND AND ARGUMENT**

- 4. It is Government policy that fees should in general be set at levels sufficient to recover the full cost of providing the services. Most Government fees and charges have been frozen since February 1998 as an exceptional measure to alleviate the financial burden on the public in times of economic difficulty. Among the environment and conservation related fees and charges proposed for revision, some were last revised in 2000-01 when the economy was gradually picking up, the rest were last revised in 1997-98. To abide by the "user pays" principle, the Financial Secretary indicated in the 2004-05 Budget Speech the need to consider the resumption of revision of Government fees and charges. In this connection, a fee revision review exercise was conducted in 2004. The review indicated that many of the fees needed to be revised based on the "user pays" principle.
- 5. We consulted the Legislative Council Panel on Environmental Affairs on 21 December 2004 on the proposals to revise the fees under the aforementioned regulations. Members of the panel did not raise any objection to the proposed fee revision. The existing and proposed fees are summarized in Annex I.

6. For this revision exercise, we propose to adjust 24 fee items, of which 14 will be reduced and 10 increased. The adjustments include the following:

#### (a) Air Pollution Control Ordinance (6 fee items)

- (i) to reduce the fee for open burning permit under the <u>Air Pollution (Open Burning) Regulation</u> by 40% to its full cost. The cost computation is shown at Annex J; and
- (ii) to increase the specified processes licence fees by 10% with a view to phasing in full cost recovery within the next 3 years, and to reduce the fee for a certified copy of an entry in the register of specified processes under the <u>Air Pollution (Specified Processes) Regulations</u> by 8% to the full cost. The cost computation is shown in Annex K; and

# (b) Ozone Layer Protection Ordinance (3 fee items)

to reduce the fees for registration and for a licence to import or export a specified consignment of a scheduled substance under the Ozone Layer Protection (Fees) Regulations by 13%, whilst the fee for a combined licence to import and export a specified consignment of a scheduled substance will be reduced by 9% to their full cost. The cost computation is shown at Annex L; and;

#### (c) Noise Control Ordinance (4 fee items)

- (i) to increase the fees payable under the <u>Noise Control (General) Regulations</u> by 20% with a view to phasing in their full cost recovery over the next six years. The cost computation is shown at Annex M; and
- (ii) to increase the fees payable under the <u>Noise Control (Air Compressors)</u>
  Regulations and the <u>Noise Control (Hand Held Percussive Breakers)</u>
  Regulations by 10% with a view to phasing in their full cost recovery over the next two years. The cost computation is shown at Annexes N and O; and

#### (d) Water Pollution Control Ordinance (10 fee items)

- (i) except for the two licence fees mentioned in (ii) below, to reduce the fees of the Water Pollution Control (General) Regulations by 8% to 24% to their full costs; and
- (ii) to increase the licence fees for discharge or deposit from industrial, institutional or commercial premises of domestic sewage only and the fees for new licence or variation or renewal of licence for discharge or deposit from domestic premises under the Regulations by 14% with a view to achieving full cost recovery within three years. The cost computation is shown at Annex P; and

# (e) <u>Dumping At Sea Ordinance</u> (1 fee item)

to reduce the fee for a copy of an entry in the register under Section 6(1)(c) of the Ordinance by 8% to its full costs. The cost computation is shown at Annex Q.

#### THE AMENDMENT REGULATIONS

7. The Amendment Regulations seek to revise the fees with effect from 1 January 2006 as set out at Annexes A to H.

#### LEGISLATIVE TIMETABLE

8. The legislative timetable is as follows –

#### **PUBLIC CONSULTATION**

9. The Environmental Affairs Panel of the Legislative Council was consulted on the proposal at its meeting on 21 December 2004. Members had no objection to the proposed revision of fees in accordance with the "user pays" principle. The Advisory Council on the Environment was consulted on the proposal at its meeting on 17 January 2005. Members supported the fee revision proposals which are in line with the "user pays" principle.

#### **PRODUCTIVITY**

10. We have been taking measures to reduce costs through implementing efficiency initiatives, reprioritizing service provision and streamlining procedures. This has been factored into the calculation of costs for the individual fee items. As a result, the majority of fees are reduced.

#### FINANCIAL AND CIVIL SERVICE IMPLICATIONS

11. The proposed fees revision will result in a net increase in revenue of \$177,720 per annum, as summarized below –

12. There are no staffing implications.

#### **OTHER IMPLICATIONS**

13. The fee proposal is in conformity with the Basic Law, including the provisions concerning human rights. Besides, the Amendment Regulations will not affect the binding effect of the aforementioned Ordinances. The proposed fee revisions will have no major

impact on the trades concerned.

### **PUBLICITY**

14. The Amendment Regulations will be published in the Gazette on 28 October 2005. A press release will be issued on the same day. A spokesman will be made available to answer media enquiries.
