IMPORT AND EXPORT (STRATEGIC COMMODITIES) REGULATIONS (AMENDMENT OF SCHEDULE 1) ORDER 2006 (AMENDMENT) ORDER 2006

(Made by the Director-General of Trade and Industry under section 6B of the Import and Export Ordinance (Cap. 60))

1. Commencement

Subject to section 6B of the Ordinance, this Order shall come into operation on a day to be appointed by the Director-General of Trade and Industry by notice published in the Gazette.

2. Strategic commodities

Explanatory Note

This Order amends the Import and Export (Strategic Commodities) Regulations (Amendment of Schedule 1) Order 2006 (L.N. 95 of 2006) to amend the Chinese names of certain chemicals.
