

**L.N. 216 of 2005****TRADE MARKS ORDINANCE (AMENDMENT OF  
SCHEDULE 1) REGULATION 2005**

(Made by the Chief Executive in Council under section 92 of the Trade Marks Ordinance (Cap. 559))

**1. Commencement**

This Regulation shall come into operation on 17 February 2006.

**2. Paris Convention Countries and  
WTO Members**

### **Explanatory Note**
