

L.N. 233 of 2005**ROAD TRAFFIC (TRAFFIC CONTROL) (DESIGNATION OF
PROHIBITED AND RESTRICTED ZONES)
(AMENDMENT) NOTICE 2005**

(Made by the Airport Authority with the approval of the Commissioner for Transport under regulation 14(1) of the Road Traffic (Traffic Control) Regulations (Cap. 374 sub. leg. G), as modified by section 1 of Part V of Schedule 2 to the Airport Authority Bylaw (Cap. 483 sub. leg. A))

1. Prohibited zones

(1) Schedule 1 to the Road Traffic (Traffic Control) (Designation of Prohibited and Restricted Zones) Notice (Cap. 374 sub. leg. U) is amended, in item 1, in column 1, by repealing paragraph (a) and substituting—

“(a) The section of Cheong Tat Road from its junction with Cheong Lin Road to a point about 745 m north of the junction.”.

(2) Schedule 1 is amended, in item 1, by repealing paragraph (c).

(3) Schedule 1 is amended, in item 1, in column 1, by adding—

“(f) The section of the access road to the bus terminus next to AsiaWorld-Expo near its junction with Sky City Road, being the area delineated by hatching on a plan numbered PSU/P330/C/0019/A and deposited in the head office of the Authority.”.

(4) Schedule 1 is amended, in item 2, in column 1, by repealing paragraph (a) and substituting—

“(a) The hotel vehicle pick-up area, being the area on Cheong Shun Road delineated by hatching on a plan numbered PSU/P250/C/00361/F and deposited in the head office of the Authority.”.

(5) Schedule 1 is amended, in item 3, in column 1, by repealing “green on a plan numbered AAHK/BL/6/001A” and substituting “in green, red or pink on a plan numbered AAHK/BL/6/001/G”.

(6) Schedule 1 is amended by adding—

“4. The taxi pick-up and staging area which is about 240 m east of the junction of Sky City Road and Airport Expo Boulevard, being the area delineated by hatching on a plan numbered PSU/P330/C/0020/A and deposited in the head office of the Authority.	All motor vehicles except taxis.”.

2. Restricted zones

- (1) Schedule 2 is amended, in item 1, by repealing paragraph (t).
- (2) Schedule 2 is amended, in item 1, in column 1, by adding—
 - (w) Sky City Road.
 - (x) Sky City Interchange.
 - (y) Airport Expo Boulevard.
 - (z) The section of Sky City Road East from its junction with Sky City Interchange to a point about 270 m north of the junction and the section of Sky City Road East from its junction with Airport Expo Boulevard to a point about 30 m south of the junction, being the areas delineated by hatching on a plan numbered PSU/P330/C/0022/A and deposited in the head office of the Authority.
 - (za) Temporary road from a point about 270 m north of Sky City Interchange to a point about 615 m north of the interchange, being the area delineated by hatching on a plan numbered PSU/P330/C/0023/A and deposited in the head office of the Authority.”.
- (3) Schedule 2 is amended, in item 3, in column 1, by repealing “The section” and substituting—
 - (a) The section”.
- (4) Schedule 2 is amended, in item 3, in column 1, by adding—
 - (b) The section of the layby of the eastbound carriageway of Airport Expo Boulevard from a point about 78 m east of its junction with Sky City Road to a point about 156 m east of the junction, being the area delineated by hatching on a plan numbered PSU/P330/C/0021/A and deposited in the head office of the Authority.”.
- (5) Schedule 2 is amended, in item 4, in column 1, by adding—
 - (c) Cheong Shun Road.”.

Explanatory Note

This Notice amends Schedules 1 and 2 to the Road Traffic (Traffic Control) (Designation of Prohibited and Restricted Zones) Notice (Cap. 374 sub. leg. U) to designate—

- (a) as prohibited zones in the Hong Kong International Airport—
 - (i) section of Cheong Tat Road and section of the access road to the bus terminus next to AsiaWorld-Expo near its junction with Sky City Road;
 - (ii) the hotel vehicle pick-up area on Cheong Shun Road; and
 - (iii) the taxi pick-up and staging area which is about 240 m east of the junction of Sky City Road and Airport Expo Boulevard; and
- (b) as restricted zones in the Hong Kong International Airport—
 - (i) Sky City Road, Sky City Interchange, Airport Expo Boulevard, sections of Sky City Road East and temporary road north of Sky City Interchange;
 - (ii) section of the layby of the eastbound carriageway of Airport Expo Boulevard; and
 - (iii) Cheong Shun Road.
