- 2. <u>Members</u> agreed to invite public views on the Bill by putting a notice on the LegCo's website on the Internet and writing to relevant parties. They also agreed that the Administration should provide the full list of consultees who/which had responded to the three-month public consultation on mandatory Energy Efficiency Labelling Scheme (EELS) launched in July 2005.
- 3. The Committee deliberated (Index of proceedings attached at **Annex A**).
- 4. The Administration was requested to -
  - (a) Provide the latest information on the electricity consumption and penetration rates of the 18 types of energy consuming products under the voluntary EELS;

Action - 3 -

- (b) Initiate the consultation process with the trades regarding the priority of and the time frame within which the remaining 15 products under the voluntary EELS should be included in the second phase of the mandatory EELS. To also consider introducing a similar mandatory scheme for energy efficiency measures in non-domestic energy consuming products;
- (c) Advise overseas experience, particularly the approach adopted and the difficulties encountered, on the implementation of mandatory EELS;
- (d) Advise the annual electricity consumption in the commercial and residential sectors. To also advise the difference in electricity consumption between a residential premises and a commercial premises of the same size;
- (e) Advise the compliance rate of the Building Energy Codes by commercial buildings; and
- (f) Provide information on the use of heat engines in promoting energy efficiency in Hong Kong.
- 5. <u>Members</u> agreed that the next meeting would be held on Friday, 1 June 2007, at 8:30 am to meet with the Administration and deputations.
