**I. Meeting with the Administration**

[LC Paper No. CB(2)1019/06-07(01) - the Administration's paper on "Education for the ethnic minorities"]

The Bills Committee deliberated (index of proceedings attached at **Annex**).

2. The Administration was requested to provide a paper on the following –

Action

- (a) explaining why a defence could be established under Clause 49 for implementing special support measures intending to bestow benefits on ethnic minorities, e.g. the special support measures to help non-Chinese speaking (NCS) students learn Chinese and inviting the University Grants Committee (UGC)-funded institutions to consider accepting alternative qualifications in Chinese in considering admissions of these students, having regard to the argument that provision of concessionary fares to persons with a disability might constitute a contravention of the Disability Discrimination Ordinance and the High Court's ruling in the case of *Equal Opportunities Commission v Director of Education* [2001] that the then Secondary School Places Allocation system was unlawfully sex-discriminatory;
- (b) whether the admission of non-local students subject to a 10% quota by UGC-funded institutions, who were predominantly Mainland students and did not need to meet the Chinese Language requirement, would be regarded as racial discrimination against local NCS students under the Bill;
- (c) whether the Administration would consider allocating a quota for admitting local NCS students to UGC-funded institutions on top of the approved student number of 14 500 for first-year-first-degree programmes, and if not, whether the Administration would give an undertaking as a matter of policy that it would implement administrative measures under Clause 49 of the Bill to support NCS students on a long-term basis which would have the effect of implementing affirmative action; and
- (d) the policy and legal considerations of the Administration for not imposing an obligation for affirmative action under the Bill.

3. The Administration was also requested to provide the following information -

- (a) details of the Belgian Linguistics Case (1968) 1EHRR 252 heard by the European Court of Human Rights and relevant citation/judgment;
- (b) information on the academic attainment of ethnic minority students in public examinations and the number of these students who had been admitted to local universities;
- (c) the number of places available for Chinese Language teachers of the designated schools to participate in the relevant training programmes and the number of these teachers; and

- (d) the number of ethnic minorities in Hong Kong who had specific needs in language, the supply of special support measures in quantitative terms from available channels to meet these needs (including the demand for and the resources allocated to the provision of remedial programmes for NCS students) and how their specific needs in receiving vocational training would be met.

- 4. The legal adviser to the Bills Committee was requested to -
  - (a) identify the major differences between the Bill and the English Race Relations Act 1976 (RRA) on which the Bill was modelled and identify issues in the provisions of the Bill and relevant case law on RRA; and
  - (b) provide the House of Lords' ruling in a case relating to the issue of whether a school places allocation system in the United Kingdom was gender-biased and unlawful.

5. At the suggestion of the Chairman, members agreed that, subject to the availability of the Administration's written response to the above issues, the Bills Committee would further discuss the subject of affirmative action as well as the Administration's paper on "Compatibility with Articles 24 and 25 of the Basic Law" [LC Paper No. CB(2)1019/06-07(04)] at the next meeting to be held on Wednesday, 28 February 2007 at 8:30 am.
