- 3) 15 School for Secondary & Primary, this is not enough. I request, select some more EM school in every district & every school has one non-Chinese, English teacher from Ethnic Minorities. The Chinese teacher must be good graduate, fluent in English because some where I talk to teacher, they are not good in English. Because non Chinese children weak in education reason of teacher. There should be good control, good discipline in the school.
- 4) In health department, they don't care to non Chinese, in the emergency they just give them yellow or green paper to non Chinese for sitting 2-4 hours because they already pay \$100 as everybody. I requested not more than I hour keep waiting, arrange more doctors. When they admit in the hospital special for Muslim people in Hong Kong. They have no food. I would like to request, Government should arrange 5 Hospitals cook Halal Food for Muslims. About 160,000 Muslims live in Hong Kong. (1) Queen Marry Hospital (2) Queen Elizabeth (3) Kwong Wah Hospital (4) Princess Margaret Hospital (5) Tuen Mun Hospital
- 5) Housing.
 - Housing Dept., very difficulty takes long time for non Chinese. So many empty flat in old house special in Urban Area & New Territory. I would like to request after the application after six month must be give house because they are having difficulty for
