Race Discrimination Bill

Thanks for your letter of 7 February 2007 and the arrangement of a briefing session on 22 February 2007, which highlighted the areas of concerns and implications of the Bill on operations of the educational institutes in Hong Kong.

The Vocational Training Council (VTC) fully supports the spirit of the Bill and the provisions in general stated therein. More importantly, we must emphasize the need for inclusion of the following provisions or exceptions in the Bill –

- The exception for Medium of Instruction and arrangements regarding holidays in education and training bodies as prescribed under Clause 26(2);
- The special measures intended for bestowing benefits on ethnic minorities and promoting equal opportunities for them not being regarded as racial discrimination (Clause 49); and
- There should not be mandatory requirement for all service providers, including educational establishments to conduct their activities and business in all languages or any specified languages (Clause 58).
