I. Election of Chairman

Ms Margaret NG was elected Chairman of the Bills Committee.

II. Meeting with the Administration

[Legislative Council Brief, the Bill, LC Paper Nos. LS64/06-07 and CB(2)1759/06-07(01) to (02)]

- 2. The Bills Committee deliberated (index of proceedings attached at Annex).
- 3. <u>The Administration</u> was requested to respond/provide information in relation to the following issues –

<u>Proposed amendments to the Bankruptcy Ordinance (Cap. 6)</u> (Part 2 of the Bill)

(a) the judgment of the Court of Final Appeal (CFA)'s case, which ruled that section 30A(10)(b)(i) of the Bankruptcy Ordinance (Cap. 6) was unconstitutional;

Action

Proposed amendments to the Public Order Ordinance (Cap. 245) and Societies Ordinance (Cap. 151)

(Part 3 of the Bill)

- (b) the judgment of CFA in *Leung Kwok Hung v HKSAR [2005] 3 HKLRD 164*, which held that "public order (in the law and order sense)" should be severed from "public order (*ordre public*)" in sections 14(1), 14(5) and 15(2) of the Public Order Ordinance (Cap. 245); and
- (c) the grounds for proposing the amendments (e.g. whether the amendments were in conformity with the CFA's judgment), whether there was a change in policy by deleting the references to "ordre public" from the two Ordinances, and whether and how the proposed amendments, if enacted, would affect the rights of Hong Kong people, in particular the rights to assembly and demonstration.
- 4. <u>The Chairman</u> suggested and <u>members</u> agreed that the Secretary for Justice be requested to provide written response on the existing mechanism for reviewing the statute book and determining the need for introducing a Statute Law (Miscellaneous Provisions) Bill as well as the timetable for the adaptation of laws programme.

5. To facilitate members' future discussion, the Chairman requested the Clerk to –

Proposed amendments to the Public Order Ordinance (Cap. 245) and the Societies Ordinance (Cap. 151)
(Part 3 of the Bill)

(a) provide extract of the relevant articles of the United Nations International Covenant on Civil and Political Rights which contained the references to "public order (*ordre public*)"; and

Proposed amendments to the Legal Practitioners Ordinance (Cap. 159) : bankruptcy of solicitors

(Part 10 of the Bill)

(b) request The Law Society of Hong Kong to advise the consultation taken with its members on the proposed amendments.

Action

- 6. Noting that the two legal professional bodies opposed to the proposed amendments to the Costs in Criminal Cases Ordinance (Cap. 492) (Part 7 of the Bill), <u>members</u> agreed that The Hong Kong Bar Association and The Law Society of Hong Kong and other parties which had been consulted by the Administration on the proposed amendments should be invited to provide views to the Bills Committee.
- 7. <u>Members</u> generally considered that the proposed amendments to the Public Order Ordinance (Cap. 245) and the Societies Ordinance (Cap. 151) (Part 3 of the Bill) were not merely textual amendments, but involved changes in policy. As there had not been public consultation on the Bill apart from Part 7, the Bills Committee agreed that a meeting should be held to receive public views on the Bill. A general notice inviting views on the subject would be posted on the Council's website. In line with the usual practice, the 18 District Councils would also be invited to submit views on the subject. Invitation letters would be issued to the parties concerned.
- 8. The Bills Committee agreed that it would first examine the policy aspects of the proposed amendments at the next meeting, followed by a clause-by-clause examination of the Bill. The Bills Committee further agreed that it would focus its discussion on the proposed amendments to the Public Order Ordinance (Cap. 245) and the Societies Ordinance (Cap.151) at the next meeting. Representatives from the Security Bureau should also be invited to attend the next meeting.

III. Dates of next meetings

- 9. <u>Members</u> agreed to schedule the next two meetings of the Bills Committee as follows
 - (a) 7 June 2007 at 8:30 am to meet with the Administration; and
 - (b) 16 June 2007 at 9:30 am to meet with deputations and the Administration.
