Clause Amendment Proposed (a) In the proposed definition of "external member", by deleting "or (h)" and substituting ", (*h*) or (*j*)"; (b) in the proposed definition of "parent member", by adding "(b)", after "6(1)"; (c) by adding after the proposed definition of "standing committee"-"students with special educational needs" (特殊教育需要學生) means students with one or more of the following characteristics -(*a*) attention deficit:

- (b) hyperactivity disorder;
- (c) autism;
- (*d*) hearing impairment;
- (e) mental handicap;
- (f) mental illness;
- (g) physical handicap;
- (*h*) specific learning difficulties;
- (*i*) speech impairment;

- (a) by deleting subsection (1) and substituting -
 - "(1) The Board of Governors shall comprise the following members
 - (a) 3 persons elected by the Chairmen of the School Councils from among their own number;
 - (b) 6 persons elected by the parents of students of schools of the Foundation that provide primary or secondary education from among their own number;
 - (c) one person elected by the parents of students with special educational needs of schools of the Foundation that provide primary or secondary education from among their own number:
 - (d) one person elected by the Committee of Parents from

among the members of that Committee;

- (*e*) one person elected by the Principals of the schools of the Foundation from among their own number;
- (f) 2 persons, one of whom is a teacher of primary level students and the other of secondary level students, elected by the Committee of Teaching Staff from among the members of that Committee;
- (g) one person elected by the Committee of Support Staff from among the members of that Committee;
- (*h*) 10 persons who are not eligible for nomination or election under any other paragraph of this subsection, nominated by the Nominating Committee;
- (i) the Chief Executive Officer, ex officio; and
- (*j*) the Permanent Secretary for Education Bureau or his appointed representative.";
- (b) in subsection (2), by deleting "or (*h*)" and substituting ", (*h*) or (*j*).".
