English Schools Foundation Amendment Bill 2007 CSAs Proposed by Hon Abraham Shek

I attach a revised draft of a the Committee Stage Amendments to be proposed by Hon Abraham Shek on behalf of ESF.

The revised draft contains a new CSA to amend proposed Section 6(3) of the Ordinance (clause 8 of the Bill).

Following the discussion that took place during the clause-by-clause scrutiny of the Bill at the last Bills Committee meeting, further consideration has been given to proposed section 6(3) of the Ordinance. As currently drafted, that provision is cast in wider terms that is necessary to achieve its intended purpose.

The effect of the new amendment is to narrow the application of section 6(3) so that, while members of the Nominating Committee continue to be debarred from nominating themselves as a member of the Board of Governors under paragraph (h) of section 6(1), they are not debarred from being nominated or elected as a member under paragraphs (a) to (g) of that subsection.

I do hope that members will support this amendment. My apologies for the lateness of the notice.
