- 3. The Administration was requested to provide a response in writing to the following issues raised by members at the meeting -
  - (a) comparison of the Administration's proposal to extend the coverage of the Prevention of Bribery Ordinance (Cap. 201) (POBO) to the Chief Executive (CE) previously submitted to the Subcommittee on Application of Certain Provisions of the Prevention of Bribery Ordinance to the Chief Executive of the Panel on Constitutional Affairs and that made under the Prevention

of Bribery (Amendment) Bill 2007 (the Bill);

- (b) the extent to which the Central People's Government had been involved in the formulation of the Bill, if any;
- (c) Commissioner, Independent Commission Against Corruption (C, ICAC), should refer a corruption complaint against CE to the Legislative Council (LegCo) if he/she had reason to suspect that CE might have committed an offence under POBO, instead of referring the complaint to Secretary for Justice (SJ), in order to enable LegCo to take any action provided under Article 73(9) of the Basic Law. Alternatively, SJ should be required to make a report to LegCo on the reason(s) for not referring a corruption complaint against CE received from C, ICAC to LegCo. Details of the report should include essential facts of the complaint such as findings of ICAC's investigation; and
- (d) the need to provide in POBO immunity to LegCo Members for inadvertently disclosing information contained in SJ's referrals, made under new section 31AA, outside the proceedings of the Council and its committees.
