I. Continue discussion on the Bill

The Bills Committee deliberated (index of proceedings attached at **Annex**).

- 2. The Bills Committee requested the Administration -
 - (a) to consider amending clause 32 along the lines of "to assist the Council in monitoring by observing.....";

- (b) to clarify what constituted "other sufficient cause" in section 3 of Schedule 2;
- (c) to consider providing that the removal of an observer from office should be endorsed by the Chief Executive;
- (d) to consider the appropriate authority for approving the fees and allowances to be paid to observers of the Independent Police Complaints Council (IPCC), making reference to the arrangements for existing statutory bodies;
- (e) to provide information on how IPCC observers were notified of the Police's interviews and collection of evidence;
- (f) to provide statistics on interviews/collection of evidence where the Police had notified IPCC in the past two years and the observers' attendance at such interviews/collection of evidence:
- (g) to provide statistics on surprise visits conducted by IPCC observers in the past two years;
- (h) to provide statistics on the reports of IPCC observers which indicated irregularities in the past two years;
- (i) to provide statistics on the declaration of interests by IPCC observers;
- (j) to advise whether an observer might conduct observation before a complaint was lodged or before a complaint was categorised;
- (k) to consider setting out in the Bill the requirement that the Police must notify IPCC of all interviews and collection of evidence before they were conducted;
- (l) to consider not obliging observers to provide opinion on whether an interview or collection of evidence has been conducted in a fair and impartial manner and to improve the form for completion by observers;
- (m) to provide the guidelines for Justices of the Peace in relation to their visits to penal institutions and the form for their completion after such visits:
- (n) to consider amending "it comes to the knowledge of" in clause 34(3) along the lines of "it appears" in relation to the requirement for IPCC observers to disclose interest;

- (o) to consider providing information to IPCC observers on how an observation should be conducted;
- (p) to provide information on the procedures applicable to observers;
- (q) to consider revising clause 35(c) to spell out that the drawing up of a duty roster of IPCC observers would not affect an observer's right to conduct observation when it was not his turn according to the duty roster;
- (r) to provide information on how an interviewee's objection to the presence of an observer would be handled; and
- (s) to consider publishing the procedures applicable to the IPCC Observers Scheme and improving such procedures.
