 - (a) to provide information on the number of interviews conducted by the Independent Police Complaints Council (IPCC) for consideration of interim investigation reports submitted by the Complaints Against Police Office (CAPO) and the reasons for conducting the interviews;

- (b) to provide information on the respective number of complaints covered by clause 9(a) to (d) in 2007 and, for complaints covered by clause 9(a) and anonymous complaints, the number of complaints involving serious abuse of police powers;
- (c) to provide information on the number of reportable and nonreportable complaints received by CAPO in 2007 and the number of anonymous complaints and complaints lodged by a person who was not the personally aggrieved party among the non-reportable complaints; and
- (d) to provide statistics on complaints lodged by a person who was not the personally aggrieved party and anonymous complaints received by IPCC in 2007, to explain how such complaints were handled by IPCC and whether IPCC had received any response from the Police regarding such complaints.
- 3. Mr James TO requested the Administration to state in the speech of the Secretary for Security at the resumption of Second Reading debate on the Bill that clause 20(1)(a) covered information and material in respect of an allegation arising from a reportable complaint that was classified as "Substantiated other than reported" in an investigation report.
