NOTE FOR FINANCE COMMITTEE

Changes to the Approved Estimates of Expenditure Approved under Delegated Authority

In accordance with section 8(8)(a) of the Public Finance Ordinance, the Financial Secretary shall, at the end of each quarter of the financial year or as soon as practicable thereafter, report to the Finance Committee changes made to the approved estimates of expenditure in that quarter upon approval by him or by any public officer pursuant to a delegation under section 8(3) or (4). This note contains details of such changes made during the first quarter of 2007-08.

- 2. During the first quarter of 2007-08, 17 applications for supplementary provisions, three applications for increases in commitments, 13 applications for new commitments, 11 applications for revote commitments and a net increase of 1 014 posts, as detailed in the Report attached, were approved under delegated authority.
- 3. The total additional funds required in the 17 applications for supplementary provision amounted to \$296,460,000. A breakdown is as follows -
