Forecast of submissions for the 2006-07 Legislative Council session

This note gives an overview of the potential capital works items to be submitted to the Public Works Subcommittee in the 2006-07 Legislative Council session.

2. The pool of items that may be ready for submission to the Public Works Subcommittee before the 2007 summer recess totals 113 as listed in Enclosure 1. To enable Members to have a better understanding of the items, we have provided supplementary information on each item at Enclosure 2 following the same order presented in Enclosure 1.

3. The Administration will try to adhere to the targets as much as possible. However, programme changes arising during the design, statutory gazettal and objections, and consultation stages, etc. are expected. We will account for deviations from the current forecast in a year-end report for Members' reference.

Project Code and Title: Provision for CWRF block allocations in 2007-08

Policy Bureau and Branch: Various controlling officers of CWRF block allocations

Works Department: Various works departments

Project Description:

To enable Members of Finance Committee (FC) and Public Works Subcommittee (PWSC) to make better use of their time and concentrate on the more important and higher value projects, FC has authorised the Administration to seek funding for the various block allocations on a lump-sum basis once every year. Within the lump sum approved for each CWRF block allocation, FC has further delegated to the Administration the power to approve expenditure on individual projects. The submission seeks PWSC's endorsement and FC's approval to the proposed total allocation for 2007-08 for various CWRF block allocations.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

Previous or planned panel consultation: We plan to consult the Legislative Council Panel on Planning, Lands and Works and Panel on Information Technology and Broadcasting in November 2006.

Project Code and Title: 6718TH – Improvement to Tung Chung Road between Lung Tseng Tau and Cheung Sha

Policy Bureau and Branch: Environment, Transport and Works Bureau (Transport Branch)

Works Department: Highways Department

Project Description:

The approved scope of the project comprises (a) widening and realignment of a 3.6-kilometre (km) section of Tung Chung Road (TCR) between Lung Tseng Tau and Pak Kung Au from a single-lane road for two-way traffic to a single two-lane road for two-way traffic, with a footpath having a minimum width of 1.6 metres (m); (b) construction of a 2.6-km long single two-lane road between Pak Kung Au and Cheung Sha with a footpath having a minimum width of 1.6 m, including elevated highway structures of a total length of 750 m; (c) provision of 21 passing bays/bus lay-bys along TCR; (d) provision of a roundabout at Cheung Sha; (e) provision of traffic control and surveillance system; and (f) the associated works including road rehabilitation, drainage, utility, environmental mitigation measures, landscaping, slope stabilization, traffic aids, road safety enhancement measures, and lighting, electrical and mechanical works.

The construction works commenced in June 2004. As the site conditions are more difficult than originally envisaged and the contract price fluctuation is much higher than expected, we need to seek additional funding from the Finance Committee to increase the approved project estimate to complete the TCR improvement works, tentatively scheduled in 2008 – Q3.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Below \$200 million

Previous or planned panel consultation: We consulted the Legislative Council Panel on Transport on the TCR improvement works on 19 January 2001, 25 January 2002 and 23 May 2003. We plan to consult the Panel on the proposed increase in approved project estimate in November 2006.

Project Code and Title: 3323EP – A 24-classroom primary school at the junction of Texaco Road and Castle Peak Road, Tsuen Wan

Policy Bureau and Branch: Education and Manpower Bureau

Works Department: Architectural Services Department

Project Description:

The proposed project is for the construction of a primary school at the junction of Texaco Road and Castle Peak Road, Tsuen Wan, to enable an existing bi-sessional primary school to turn whole-day operation. The proposed school premises comprises 24 classrooms, supporting rooms and other ancillary facilities. The construction is tentatively scheduled to commence in 2006 – Q4 for completion in 2008 – Q4.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$ 500 million): Below \$200 million

Previous or planned panel consultation: In October 2005, we consulted the Legislative Council Panel on Education (Education Panel) on the proposed adjustments to the School Building Programme in the light of the latest population projections and other developments in the education sector. The Education Panel noted our plan to proceed with school projects for converting existing bi-sessional primary schools to whole-day operation, i.e. the category under which the proposed project falls.

Project Code and Title: 4112CD – Drainage improvement in Northern New Territories - package A

Policy Bureau and Branch: Environment, Transport and Works Bureau (Works Branch)

Works Department: Drainage Services Department

Project Description:

The part proposed for upgrading to Category A covers the improvement works to the existing drainage systems in Ping Kong, Kau Lung Hang, Yuen Leng, Nam Wa Po and Tai Hang areas. The proposed scope of the project comprises upgrading of about 4.5 km of drainage channels and ancillary roadworks. The construction is tentatively scheduled to commence in 2006 – Q4 for completion in 2010 – Q4.

We previously sought funding approval from the Finance Committee –

- (a) on 22 June 2001 for part upgrading the project to Category A as 4116CD “Drainage Improvement in Northern New Territories - package A – consultants’ fees and investigations” for employing consultants to carry out preliminary design, environmental and traffic impact assessment and investigation works;
- (b) on 4 March 2005 for part upgrading the project to Category A as 4137CD “Drainage improvement for Ma Wat River at Kau Lung Hang” for the construction of Ma Wat drainage channel at Kau Lung Hang and drainage pipe crossings under the East Rail embankments at Kau Lung Hang and north of Hong Lok Yuen; and
- (c) on 17 February 2006 for part upgrading the project to Category A as 4145CD “Upgrading of stormwater drains in Sheung Shui and Fanling” for improving the capacity of the drainage system in the areas concerned.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): \$200 million - \$500 million

Previous or planned panel consultation: We consulted the Legislative Council Panel on Planning, Lands and Works on the proposed works on 25 July 2006. Members did not raise any objection to the proposal.

The proposed school premises comprises 24 classrooms, supporting rooms and other ancillary facilities. The construction is tentatively scheduled to commence in 2007 – Q1 for completion in 2008 – Q4.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$ 500 million): Below \$200 million

Previous or planned panel consultation: In October 2005, we consulted the Legislative Council Panel on Education (Education Panel) on the proposed adjustments to the School Building Programme in the light of the latest population projections and other developments in the education sector. The Education Panel noted our plan to proceed with school projects for converting existing bi-sessional primary schools to whole-day operation, i.e. the category under which the proposed project falls.

Works Department: Architectural Services Department

Project Description:

The proposed project is for the improvement of the Victoria Park Tennis Centre.
