#### PART I PLEASURE GROUNDS

Public Health and Municipal Services Ordinance (Cap. 132)

Public Health and Municipal Services (Setting Aside Places for Use as Public Pleasure Grounds) Order 2007 (L.N. 57)

Public Health and Municipal Services Ordinance (Amendment of Fourth

Public Health and Municipal Services Ordinance (Amendment of Fourth Schedule) Order 2007 (L.N. 58)

- L.N. 57 sets aside the places specified in Schedule 1 to the Order for use as public pleasure grounds under the Public Health and Municipal Services Ordinance (Cap. 132), and provides that Lai Chi Kok Temporary Recreation Ground ceases to be set aside for use as such public pleasure ground.
- 2. L.N. 58 amends the Fourth Schedule to Cap. 132 to update the list of public pleasure grounds.
- 3. Under section 107 of Cap. 132 and by virtue of the Third Schedule to Cap. 132, the general management and control of places set aside as pleasure grounds shall be vested in the Director of Leisure and Cultural Services.

### PART II DECLARATION OF PROPOSED MONUMENT

Antiquities and Monuments Ordinance (Cap. 53)
Antiquities and Monuments (Declaration of Proposed Monument) (No. 128 Pok Fu Lam Road) Notice (L.N. 59)

4. This Notice declares the buildings and the adjoining land situated within

the Rural Building Lot No. 324, No. 128 Pok Fu Lam Road, Hong Kong, delineated and shown edged red on the plan marked Plan No. HKM7486c to be signed by the Secretary for Home Affairs and deposited in the Land Registry in accordance with section 2A(4) of the Antiquities and Monuments Ordinance (Cap. 53), together with all structures erected on such land to be a proposed monument for a period of 12 months from 20 April 2007.

- 5. Under section 2C of Cap. 53, the owner or any lawful occupier of private land within which a proposed monument has been declared may at any time apply to the Secretary for Home Affairs for withdrawal of the declaration.
- 6. Members may refer to the LegCo Brief issued by the Home Affairs Bureau in April 2007 (File Ref: HAB/CS/CR 4/1/83) for background of this Notice.
- 7. The above three items of subsidiary legislation have not been referred to the Home Affairs Panel.
- 8. The drafting of the above subsidiary legislation is in order.
