## I Election of Chairman/Deputy Chairman

### Election of Chairman

Ir Dr Raymond HO presided at the election. Ms Miriam LAU Kin-yee was nominated by Mr LAU Kong-wah and the nomination was seconded by Mr Abraham SHEK Lai-him. Mr LAU Kong-wah stated that he had already secured Ms Miriam LAU's acceptance of the nomination in her absence. As there was no other nomination, Ir Dr Raymond HO declared Ms Miriam LAU elected as Chairman of the Subcommittee.

#### Election of Deputy Chairman

- 2. <u>Members</u> agreed that a Deputy Chairman should be elected. <u>Ir Dr Raymond HO</u> called for nominations for the deputy chairmanship of the Subcommittee.
