3. The Subcommittee requested the Administration -

Shenzhen Bay Port Hong Kong Port Area (Permission to Enter) Notice

- (a) to explain, from a legal point of view, the meaning of the term "immediate vicinity" in the Schedule to the Notice and to provide the Police's guidelines given to officers on the handling of emergency situations such as a traffic accident in which a driver or passenger had to leave a vehicle within the closed area;
- (b) to consider adding a provision to the Schedule to the Notice to

cater for the situation where a person had a need to return to the Mainland immediately after entering Hong Kong via the Passenger Terminal Building;

Immigration (Places of Detention) (Amendment: Shenzhen Bay Port Hong Kong Port Area) Order 2007 and Immigration Service (Designated Places) (Amendment: Shenzhen Bay Port Hong Kong Port Area)) Order 2007

- (c) to advise whether persons arrested in other parts of Hong Kong would be detained in the area within the Clearance Area of the Shenzhen Bay Port Hong Kong Port Area that was set aside as detention quarters for use by the Immigration Department.
- 4. The Administration agreed to provide advance and clear signage and proper marks on the road surface to indicate clearly to the motorists the entry point of the closed area at the Deep Bay Link.

- 5. The Subcommittee agreed that the next meeting would be held on 5 June 2007 at 10:45 am to continue discussion with the Administration.
- 6. The Subcommittee agreed that the Chairman should move a motion at the Council meeting on 30 May 2007 to extend the scrutiny period of the five items of subsidiary legislation to 27 June 2007.
