I. Meeting with the Administration

The Subcommittee deliberated (index of proceedings attached at Annex).

2. The Subcommittee requested the Administration to provide a response to the following issues raised by members -

Fugitive Offenders (Corruption) Order

- (a) to consider -
 - (i) deleting everything in the Schedule to Fugitive Offenders (Corruption) Order (the Order) except Article 44(8);
 - (ii) deleting everything in the Schedule to the Order except Article 44; or
 - (iii) giving an undertaking or statement to emphasise that Article 44(8) was the only operative provision in the Schedule to the Order;

Organized and Serious Crimes Ordinance (Amendment of Schedule 2) Order 2007

- (b) to explain the differences, including the scope of application and burden of proof, between a restitution order under section 12 of the Prevention of Bribery Ordinance (POBO) and a confiscation order under Schedule 2 to the Organized and Serious Crimes Ordinance (OSCO);
- (c) to explain the effect, if any, of the proposed amendments to Schedule 2 to OSCO on existing agreements on mutual legal assistance in criminal matters (MLA) and surrender of fugitive offenders, including whether a jurisdiction with which Hong Kong had not concluded an MLA agreement could seek MLA under the proposed amendments to Schedule 2 to OSCO;

- (d) to advise if the Administration was aware of any countries where proceeds from corruption could only be recovered by way of a civil order; and
- (e) to advise whether there were difficulties in the enforcement of an order issued under section 12 of POBO.
- 3. The Subcommittee requested the Clerk to identify from the records of the committee which studied the Organized Crime Bill 1991 the reasons for not including the offences on "accepting" bribes as defined under sections 4(2), 5(2), 6(2) and 9(1) of POBO in Schedule 2 to OSCO.

II. Date of next meeting

- 4. <u>The Chairman</u> concluded that the Subcommittee had completed its scrutiny of the Order and a written report on the deliberations of the Subcommittee would be submitted to the House Committee on 5 October 2007. She informed members that the deadline for moving a motion to repeal the Order would be 10 October 2007. <u>Mr James TO</u> disagreed that the Subcommittee had concluded its scrutiny of the Order, as there was still information on the Order to be provided by the Administration.
- 5. The Subcommittee agreed that the next meeting would be scheduled to continue discussion with the Administration on the Organized and Serious Crimes Ordinance (Amendment of Schedule 2) Order 2007 and the Mutual Legal Assistance in Criminal Matters (Corruption) Order, pending the availability of the information to be provided by the Administration.
- 6. The meeting ended at 10:15 am.
