Legislative Council Panel on Education Follow-up Information on Disposal and Use of Vacant School Premises

Purpose

At the meeting held on 14 May 2007, Members asked the Administration to provide –

- (a) information on number of schools which are potential candidates for reprovisioning; and
- (b) site-specific and hardware information on premises of schools that have ceased/will cease operation under the consolidation policy since the 2003/04 school year.

This paper provides the information requested.

Potential Candidates for Reprovisioning

- 2. In-situ improvements to physical facilities of schools built to old planning standards and designs have been provided under the now complete School Improvement Programme (SIP) as far as practicable. However, owing to physical or technical constraints such as lack of space, the extent of improvements is limited in some cases, in particular for works carried out under Phases 1 to 3 of the Programme¹.
- 3. Depending on the availability of suitable reserved school sites and financial resources, we have been reprovisioning schools housed in sub-standard premises. We have generally regarded those schools with site area less than 3 000 square metres and premises over 30 years old, without having benefited or having only marginally benefited from the SIP, as warranting our serious consideration for reprovisioning. However, this is not a prerequisite since, for each site/premises to be made available for

reprovisioning, the priority of each application received has to be assessed with reference to a number of considerations which are not limited to physical conditions, such as the location of the existing school premises vis-à-vis the new location and the enrolment situation, operating standards as well as development proposals of the schools concerned. In other words, we do not have a definitive list of schools which are "eligible" for reprovisioning. To give Members a ballpark indication of the number of schools that may warrant serious consideration for reprovisioning just on the ground of physical conditions, among those schools which are either SIP non-feasible or only included in Phases 1 to 3 of the SIP, our record shows that some 39 primary schools and six secondary schools are built more than 30 years ago on school sites with less than 3 000 square metres. The majority of them are located in urban districts.

Details of School Premises Vacated under the Consolidation Arrangements

- 4. We have reported in LC Paper No. CB(2)1781/06-07(01) that 54 primary schools have ceased/will cease operation under the consolidation policy up to the 2007/08 school year, and some 25 schools currently without Primary One may close beyond the 2007/08 school year under the consolidation arrangements.
- 5. In response to Members' request, site-specific and hardware information including the district, site area, age of building, number of classrooms and special rooms, availability of school hall, completion date of SIP works (if any) of these premises is provided at **Annex A**.

School Premises Vacated due to Other Reasons

6. As set out in paragraph 2 of LC Paper No. CB(2)1781/06-07(01), all along individual school premises may become vacant for various reasons, e.g. after reprovisioning of a school to better-facilitated premises, after a school has ceased to operate, after a school has merged with another school and started to operate from another location, etc. Understandably more premises have and would become vacant after the introduction of the

consolidation arrangements for primary schools since the 2003/04 school year and it is in this context that the Education Bureau (EDB) and other relevant departments have to plan ahead and co-ordinate the disposal and re-use of vacant school premises systematically. For premises vacated before and outside the consolidation policy, they have already been dealt with over the years on a case by case basis, and have either been recycled for further educational uses, returned to the Government for disposal (some have been demolished) or kept by the lessees under lease conditions. It will not be too meaningful for EDB to retrieve records of such cases over the years.

7. That said, for good planning, we will certainly include those premises to be vacated outside the consolidation arrangements when we examine the potential of premises to be recycled for education uses. For Members' information, we currently envisage that about 18 primary and secondary school premises would be vacated in or beyond the 2007/08 school year due to reasons other than consolidation (Annex B). The majority of these premises have either been allocated or earmarked for educational uses such as extension of neighbouring schools, decanting premises for schools undergoing in-situ redevelopment, expansion of international schools, whole-day conversion of bi-sessional primary schools, etc.

Updating

8. We will continue to work with other bureaux/departments in facilitating the gainful use of re-useable vacant school premises. Some of the premises may no longer be suitable for educational uses. We will, as suggested by Members, share information on the vacant premises with other bureaux/departments which may wish to contemplate other uses for the sites/premises in question.

Note 6: For schools anticipated to close beyond the 2007/08 school year under the consolidation arrangements, it should be noted that whether the schools concerned will cease operation is subject to any future development plan that the schools may have. The precise timing in which the schools will cease operation also depends on the discussion between this Bureau and the school management concerned. Given the high uncertainty of the possible school closure, we have given an approximate number of some 25 in LC Paper No. CB(2)1781/06-07(01).
