Action

I. Further discussion on preservation of the open-air bazaar in Tai Yuen Street and Cross Street

[LC Paper Nos. CB(2)2417/06-07(01)-(03)]

<u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

- 2. <u>The Subcommittee</u> received views from individuals and representatives of deputations attending the meeting. <u>Members</u> noted that the following organisations which did not send representatives to the meeting had provided submissions for members' reference -
 - (a) Yook Tong Estates Limited [LC Paper No. CB(2)2545/06-07(09)];
 - (b) Wan Chai District Council (WCDC) [LC Paper No. CB(2)2545/06-07(10)]; and
 - (c) Hong Kong Institute of Architects [LC Paper No. CB(2)2563/06-07(01)].

Action

- 3. The Administration explained that it was necessary to relocate the fixed hawker pitches at Tai Yuen Street (South) and Cross Street (East) mainly because the dead-end layout of Tai Yuen Street (South) was not adequate to meet traffic demand generated by new residential and commercial development in the area. According to the traffic assessment of the Transport Department (TD), it was necessary to open up the road sections concerned to allow vehicles entering Tai Yuen Street (South) to exit through a one way traffic system by way of Cross Street (East) and Wai Chai Road instead of reversing or U-turning back to Queen's Road East. If these road sections were not opened for vehicular traffic, the traffic problems could not be resolved and the reversing and U-turning vehicular movements would increase the risk of traffic accident. The Administration considered that the relocation arrangement had balanced the interests of various parties.
- 4. <u>Members</u> shared the deputations' views that the entire open-air bazaar should be preserved for its special characteristics and high tourism value as well as its importance to the livelihood of hawkers concerned. <u>Members</u> considered that relocating 86 licensed fixed pitch hawkers at Tai Yuen Street (South) and Cross Street (East) as currently proposed by the Administration would substantially affect the customer flow and the business of the bazaar, which was tantamount to wiping the bazaar out of existence.
- 5. <u>Members</u> in general did not accept the justifications put forward by TD. They considered that there should be other feasible options of traffic arrangements which would not require the relocation of the fixed hawker pitches at Tai Yuen Street (South) and Cross Street (East). <u>Members</u> requested the Administration to come up with new options on traffic arrangements which would allow the preservation of the entire open-air bazaar.
- 6. <u>Members</u> also appreciated the worries of the affected hawkers and stall tenants of Wan Chai Market about the new market's poor design which would render it difficult to attract customers. <u>The Administration</u> was requested to review the design of the New Wan Chai Market with a view to addressing the concerns of the affected hawkers/stall tenants.
- 7. After discussion, <u>Dr Fernando CHEUNG</u> moved the following motion –

"That this Subcommittee urges the Government to immediately formulate a conservation policy on open-air bazaars before taking any further actions to demolish the bazaar in question, so as to preserve local characteristics and protect local community economy."

<u>The Chairman</u> put the motion to vote. The motion was supported by all members present. <u>The Chairman</u> declared that the motion was carried.

8. The Chairman suggested to the Chairman and two members of WCDC, all of whom attended this meeting in personal capacities, that it would be desirable if WKDC would reconsider the issue of preservation of the entire open-air bazaar taking into account the updated information and current views of stakeholders, and make its stance clear to the Administration to facilitate the Administration's consideration of the way forward for the open-air bazaar.

9. <u>Members</u> agreed that another meeting should be held in late September or early October 2007 to further discuss the preservation of the open-air bazaar in Tai Yuen Street and Cross Street with the Administration.
