**Legislative Council Panel on Housing  
Follow-up actions arising from the Meeting of 5 Feb 2007**

Thank you for your letter of 6 February 2007. Our response to the questions raised by Members on Housing for Senior Citizens (HSC) at the meeting of the Panel on Housing on 5 February 2007 is as follows.

A Member proposed at the meeting that the Housing Department (HD) should provide free power supply for HSC to reduce tenants' expenditure. The HD has been providing quality service and facilities in HSC. At present, lights and power sockets of the shared facilities in the units, e.g., kitchens, bathrooms and living rooms, are provided with independent power supply and power sockets. Tenants pay their electricity charges in accordance with the user-pays principle. The HD has no plan to provide free power supply to tenants. Furthermore, the HD has provided public lighting in common areas of HSC, including corridors and recreation rooms. The HD will consider, on a case-by-case basis, improving public lighting facilities when necessary.

The numbers and vacancy rates of different types of HSC units are set out at the Annex. We will continue our effort to reduce the vacancy rate of HSC. As requested by Members, we will continue to monitor and review the letting position of HSC from time to time, and report to the Legislative Council Panel on Housing in the 2007/08 session.
