Reply to follow-up questions raised by Members of the Public Service Panel at the meeting on 25.6.2007 (LC Paper No. CB(1)1915/06-07(02))

Item 4(a)

In determining the level of punishment to be imposed on an officer convicted of a criminal offence, the disciplinary authority will examine the background and circumstances of each case carefully, and take into account the following factors –

- (a) the gravity of the convicted criminal offence (which depends on but not limited to a number of considerations, such as whether the offence is duty-related, whether it has reflected adversely on the officer's integrity, whether it is premeditated, whether it is a repeated incident, the officer's position in the civil service, etc.);
- (b) the service and disciplinary record of the officer;
- (c) relevant mitigating factors; and
- (d) the customary level of punishment revealed in precedents of a similar and comparable nature.

The gravity of the convicted criminal offence will be the primary consideration. Where applicable, the disciplinary authority will consult the Public Service Commission before determination of the punishment.
