DESIGNATION OF MUSEUMS (AMENDMENT) ORDER 2007

(Made by the Director of Leisure and Cultural Services under section 105G of the Public Health and Municipal Services Ordinance (Cap. 132))

1. Commencement

This Order shall come into operation on 16 March 2007.

2. Cessation of designation as museums

The following premises shall cease to be designated as museums—

- (*a*) the Tea Room, Galleries 1, 2 and 3 and the North Lawn of the Flagstaff House Museum of Tea Ware, Victoria Barracks;
- (b) the Lobby and the Podium on 1/F of the Hong Kong Museum of Art, at 10 Salisbury Road, Tsim Sha Tsui, Kowloon;
- (c) the Lecture Hall, the Activity Rooms 1 and 2, the Special Exhibition Gallery and the Courtyard of the Hong Kong Museum of History, 100 Chatham Road South, Tsim Sha Tsui;
- (d) the Theatre, the Seminar Room, the Education Studio, the Function Place, the Courtyard and the Main Foyer (including the Grand Staircase) of the Hong Kong Heritage Museum, 1 Man Lam Road, Sha Tin;
- (e) the Cinema and the Exhibition Hall of Hong Kong Film Archive, 50 Lei King Road, Sai Wan Ho; and
- (f) the Lecture Hall in the extension block connecting Blocks S61 and S62, the Activity Room in Block S62, and the Courtyard and Cafeteria between Blocks S61 and S62, of Hong Kong Heritage Discovery Centre, Kowloon Park, Haiphong Road, Tsim Sha Tsui, Kowloon.

3. Schedule amended

The Schedule to the Designation of Museums Order (Cap. 132 sub. leg. P) is amended—

(a) by repealing "The Flagstaff House Museum of Tea Ware, Victoria Barracks." and substituting "The Flagstaff House Museum of Tea Ware (excluding the Tea Room, Galleries 1, 2 and 3 and the North Lawn set aside for use as a civic centre under section 105M of the Ordinance), 10 Cotton Tree Drive, Central.";

- (b) in the item relating to the Hong Kong Museum of Art—
 - (i) by repealing "the Painting Studio and the Printmaking Studio" and substituting "the Painting Studio, the Printmaking Studio, the Lobby and the Podium on 1/F";
 - (ii) in the English text, by adding "of the Ordinance" after "section 105M";
- (c) by repealing "The Hong Kong Museum of History, 100 Chatham" and substituting "The Hong Kong Museum of History (excluding the Lecture Hall, the Activity Rooms 1 and 2, the Special Exhibition Gallery and the Courtyard set aside for use as a civic centre under section 105M of the Ordinance), 100 Chatham";
- (d) in the item relating to the Hong Kong Science Museum, in the English text, by adding "of the Ordinance" after "section 105M";
- (e) by adding "(excluding the Theatre, the Seminar Room, the Education Studio, the Function Place, the Courtyard and the Main Foyer (including the Grand Staircase) set aside for use as a civic centre under section 105M of the Ordinance)" after "The Hong Kong Heritage Museum";
- (f) by adding "(excluding the Cinema and the Exhibition Hall set aside for use as a civic centre under section 105M of the Ordinance)" after "Hong Kong Film Archive";
- (g) in the item relating to Hong Kong Heritage Discovery Centre, by repealing "and the courtyard and cafeteria between them" and substituting "but excluding the Lecture Hall in the extension block, the Activity Room in Block S62 and the Courtyard and Cafeteria between Blocks S61 and S62 set aside for use as a civic centre under section 105M of the Ordinance".
