Proposed Committee Stage Amendments – The First Batch

Purpose

This paper explains the Administration's proposed Committee Stage Amendments ("CSA") to the West Kowloon Cultural District Authority Bill ("the Bill") in response to suggestions by Members.

Proposed CSAs

2. The Administration intends to propose CSAs in response to Members' views and suggestions. The first batch of the proposed CSAs covering Clauses 4, 5, 8, 30A, 31 and 34 are at **Annex**. The rationales of the proposed CSAs are as follows:

Clause 4(2)

3. Clause 4(2) of the Bill provides that the West Kowloon Cultural District Authority ("WKCDA"), when performing its functions under Clause 4(1), is to have regard to one or more of the purposes listed under Clause 4(2). Taking into account Members' views, we intend to propose CSAs to revise Clause 4(2) requiring the WKCDA to carry out its functions in ways which are conducive to achieving a number of objectives set out in the revised Clause 4(2). The objectives have been drawn up with regard to the purposes included in the existing Clause 4(2), but they are expressed in a more forthcoming manner.

Clauses 5(2)(n) and 5(3)

4. Clause 5(2)(n) empowers the WKCDA to "engage in such activities as the Chief Executive in Council may, after consultation with the Authority, permit or assign to it by order published in the Gazette". Clause 5(3) specifies that an order under Clause 5(2)(n) is a subsidiary legislation. Taking into account Members' views and the functions and powers of the Authority under other provisions of the Bill, we intend to propose CSAs to delete Clause 5(2)(n) and Clause 5(3).

Clause 8

5. Clause 8 provides for matters related to the Audit Committee. Taking into account Members' views, we intend to move CSAs to specify that the chairman of any other committee established under the Ordinance is not eligible for appointment as a member of the Audit Committee. This would strike a reasonable balance between the need to ensure the independence of the Audit

Committee and to have adequate members familiar with the operation of the WKCDA. The proposed CSAs will specify explicitly that members of the Audit Committee may comprise individuals who are Board members or those who are not Board members. The proposed CSAs will also change the Chinese rendition of "member of Audit Committee" from "審計委員會成員 to "審計委員會委員" to tally with the wording used in Clause 9. We would also propose that, in line with the practice of listed companies, the Audit Committee should include at least one member with appropriate professional qualifications or accounting or related financial management expertise. This will be included in a revised CSA on Clause 8.

Clause 30A and 31

6. Clause 31 requires the WKCDA to submit to the Financial Secretary annually (a) a report on the activities of the Authority, (b) a copy of the statement of accounts and (c) a copy of the Auditor's report. The proposed CSA seeks to include all these three documents into one single document – the annual report, which is the common practice among statutory bodies. In response to Members' concerns, the proposed CSAs also specify that the annual report must specify how the activities of the Authority for that financial year relate to the Authority's functions and objectives specified in Clause 4.

Clause 34

- 7. Clause 34 provides for matters related to disclosure of interest. It requires a Board or Committee member to disclose his interest upon his first appointment and on such occasion as the circumstances may require after the appointment. In response to Members' views and to make the responsibility of the Board or Committee member in this respect clearer, we intend to move CSAs to require (in addition to the existing requirement of disclosing interest upon first appointment) a Board or Committee member to disclose his interest at the beginning of each calendar year after the appointment, on first becoming aware of the existence of an interest not previously disclosed and after the occurrence of any change to an interest previous disclosed.

 - "(4A) A person is not eligible for appointment as a member of the Audit Committee if $\ -$
 - (a) he is the Chief Executive
 Officer or any other employee
 of the Authority; or
 - (b) he is the chairman of any other committee established under this Ordinance.".

New

By adding -

"30A. Annual report

- (1) The Authority shall, in respect of each financial year, prepare an annual report of the Authority for that financial year.
- (2) Without limiting the matters that the Authority may include in it, the annual report must -
 - (a) specify the activities of the Authority for that financial year and how they relate to the Authority's functions and the objectives specified in section 4;
 - (b) include the statement of accounts prepared under section 25(2) for that financial year; and
 - (c) include the report submitted
 under section 26(3)(b) for that
 financial year.".
- In the heading, by deleting "Reports, etc." and substituting "Annual report".
- 31 By deleting subclause (1) and substituting -
 - "(1) The Authority shall, within 6 months after the end of each financial year, submit to the Financial Secretary the annual report
