#### I Confirmation of minutes of meeting and matters arising

- 3. The Bills Committee deliberated (index of proceedings attached at Annex).
- 4. Mr Andrew CHENG indicated his support for raising the maximum imprisonment term for causing death by dangerous driving from five to 10 years. He however considered the proposed additional penalties for drink driving not heavy enough to reflect the serious nature of the offence, which in his view was similar to the offence of causing death by dangerous driving which carried much heavier penalties. In order to send a strong message to motorists that drink driving was not in any way

tolerated in Hong Kong, he proposed to disqualify a drink driving offender from driving for not less than one year (instead of three months as suggested by the Administration) on a first conviction and for not less than two years for a second or subsequent conviction.

- 5. In response, the Administration pointed out that the prescribed limit of blood alcohol concentration (BAC) level in Hong Kong was more stringent than that in many places, and that the Police would also be empowered to conduct random breath tests (RBTs). With a basket of control measure, the Administration considered that the proposed additional penalties were sufficient to achieve a strong deterrent effect against drink driving. Mr Andrew CHENG was unconvinced, and urged the Administration to review the matter. He indicated that he would consider moving a Committee Stage amendment to the Bill to lengthen the duration of disqualification from not less than three months to not less than one year on a first conviction of drink driving and suitably lengthen the duration for a second or subsequent conviction if the Administration was not prepared to do so.
- 6. Also dealing with the levels of penalties for drink driving, the Chairman remarked that consideration might be given to imposing different levels of penalties for different BAC levels beyond the prescribed limit. Messrs James TIEN and Andrew CHENG also considered it worthwhile to examine the desirability of the proposal. In response, the Administration said that imposing different levels of penalties for different BAC levels beyond the prescribed limit might give the wrong impression that different BAC levels had varying degrees of acceptability. Moreover, the Judiciary would look at the circumstances of individual cases when deciding on the sentences and impose heavier sentences as necessary
- 7. Where the conduct of RBTs was concerned, <u>Messrs Andrew CHENG and James TIEN</u> were keen to ensure that the Police would use the power concerned properly, and stressed the importance of drawing up clear guidelines in this regard for police officers to follow. <u>The Administration</u> assured members that proper control would be in place to prevent abuse.
- 8. Referring to the long title of the Bill, <u>Mr James TIEN</u> opined that drink driving should not be singled out for imposition of additional penalties because use of hand-held mobile phone while driving was equally dangerous. In his view, all dangerous driving behaviours which had caused death should be handled seriously in the same way. <u>Mr Andrew CHENG</u> shared his view, and proposed that the Administration should take the opportunity of this legislative amendment exercise to propose additional penalties for this offence as well. In response, <u>the Administration</u> explained that at present, if the case warranted, the Police could choose to prosecute the driver concerned for committing the offence of careless driving or dangerous driving which carried a higher penalty.
- 9. <u>Mr James TIEN</u> also expressed concern that the actual sentences imposed by the court for traffic offences always fell short of the existing maximum penalty levels. <u>The</u>

<u>Administration</u> replied that when the proposed penalties for various traffic offences were approved by the Council, the courts would take this into account when deciding on the actual sentences.

10. <u>Mr Andrew CHENG</u>, on another front, expressed concerns about the hazards posed by "holders of frozen driving licences" (i.e., those driving licence holders who did not drive for a long time after they had been issued a driving licence). <u>The Administration</u> replied that it was difficult to identify this group of drivers but it would step up publicity and education to promote the safety awareness of drivers.

#### Follow-up actions

11. To address members' concerns above, the Administration was requested to provide before 3:00 pm, 3 April 2008 information on the following –

Penalties on causing death by dangerous driving

- (a) Statistics on the penalties imposed by the court for offences of dangerous driving causing death in the past five years;
- (b) Information about overseas sanctions for offences of dangerous driving causing death;

Penalties on drink driving offences and screening breath tests

- (c) Paper on studies conducted by the Administration on the effect of alcohol on drivers;
- (d) Administration's view in response to members' proposal of imposing different levels of penalties for different BAC levels beyond the prescribed limit, and information on overseas practices in this regard, if any;
- (e) Information about overseas sanctions for drink-driving offences, including the prescribed limits of BAC levels;
- (f) Paper on the internal guidelines to be drawn up by the Hong Kong Police Force to enable police officers to conduct RBTs;
- (g) Paper on overseas experience in the implementation of RBTs, including guidelines drawn up by overseas law enforcement agencies for the purpose, and whether there had been precedents of legal challenges against RBTs conducted by them;
- (h) Comparison of the number of traffic accidents caused by the use of hand-held mobile phone while driving with that of drink driving, as well as

the respective percentages of these two types of accidents involving deaths and serious injuries; and

(i) Information about restrictions imposed by overseas jurisdictions on novice drivers of various types of vehicles.

12. <u>Members</u> noted that the next meeting of the Bills Committee would be held on Monday, 7 April 2008, at 8:30 am. They agreed that the Clerk should remind members absent from this meeting to attend the 7 April 2008 meeting if they wished to examine the policy issues arising from the Bill.
