The Administration understood from the Institution that, after the relaxation of its membership criteria, its Honorary Fellows, Fellows and Members who are either Chartered Engineers registered with the Engineering Council UK or Corporate Members of IEEHK before 15 October 2002, could meet the criteria of Fellows and Corporate Members before the relaxation of membership criteria;	
		(c) in April 2006, the IEEHK merged with the Institution of Incorporated Engineers and changed its name to IETHK; and	
		(d) according to IETHK, its membership criteria remained stringent. Fellows and Members entitled to vote at general meetings of the IETHK were either Chartered Engineers or those who had met professional qualifications

		Concerns raised by IETHK -	requireu
		(a) the eligibility requirements for members of IT organizations to register as electors were different; this constituted unfair and unequal treatment towards members of IT and should be rectified;	
		(b) proposed section 20Z(1)(f)(i) and (ii) which sought to confine eligibility of IETHK's ITFC electors to "(i) persons registered as Chartered Engineers with the Engineering Council UK; or (ii) Corporate Members of the IEEHK before 15 October 2002" was discriminatory towards its members. Fellows and Members of IETHK entitled to vote at general meetings should all be qualified as electors of ITFC; and	
		(c) the proposed amendment was divisive and would create administrative difficulties to IETHK. IETHK proposed to delete proposed section 20Z(1)(f)(i) and (ii)	
		Response of IETHK to members' queries -	
		(a) IEEHK had 6000 members in 2002. IETHK currently had 5390 members, of which 5000 were entitled to vote at general meeting of IETHK and 2950 were Chartered Engineers. Some of its members were qualified as Chartered Engineers but had not registered with the Engineering Council UK. Some members were also members of other IT organizations and were eligible electors in that capacity;	
		(b) after 15 October 2002, the term "Corporate Members" was replaced by "Members" of IEEHK. Due to time constraint, IEEHK was unable to propose amendments to LCO to reflect the changes in time. As a result, some "Members" of IEEHK were not eligible to vote in the 2004 LegCo election because they were not "Corporate Members";	
		(c) IETHK had discussed with the Administration on different occasions on the proposed amendments to LCO

		(d) IETHK confirmed that IEEHK's members who were eligible to vote as electors in the ITFC in the 2004 LegCo election would not lose their right to vote in the 2008 LegCo election as a result of the proposed amendment. It also confirmed that if its proposed removal of the amendment in section 20Z(1)(f)(i) and (ii) was accepted, the number of its members who would be eligible to register as electors would increase by more than 1,000
