I. Meeting with the Administration

<u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).

Proposed amendments to various Ordinances containing offence provisions with the drafting formula "to the satisfaction of" an enforcement agency (Parts 2 to 4 of the Bill)

2. Referring to its letter dated 29 May 2008 (LC Paper No. CB(2)2120/07-08(01)), the Administration advised that it proposed to withdraw Parts 2 to 4 of the Bill, and it would move Committee Stage amendments (CSAs) to this effect. The Administration further advised that it would reintroduce in a future bill on the amendments relating to the drafting formula "to the satisfaction of" an enforcement agency. Members raised no objection to the Administration's proposal.

Resumption of Second Reading debate on the Bill

3. <u>The Chairman</u> said that the full set of CSAs proposed by the Administration would be circulated to members for consideration. If members had no further comments on the proposed amendments, the Bills Committee would report its deliberations to the House Committee on 13 June 2008. <u>The Administration</u> advised that it intended to resume the Second Reading debate on the Bill at the Council meeting on 2 July 2008.
