835TH PWSC(2008-09)11 (Head 706)	Hong Kong-Zhuhai-Macao Bridge preconstruction works	To recommend to Finance Committee the upgrading of 835TH to Category A at an estimated cost of \$46.6 million in money-of-the-day prices for the preconstruction works for the Hong Kong-Zhuhai-Macao Bridge.
