Yung Shue Wan and Sok Kwu Wan Sewerage Projects (230DS and 234DS) Supplementary Information on Land Resumption and Clearance Cost

In considering the paper referenced PWSC(2007-08)49 on 230DS and 234DS at the PWSC meeting on 31 October 2007, some Members enquired about the difference in the land resumption and clearance costs of the Yung Shue Wan and Sok Kwu Wan sewerage projects (230DS and 234DS). We explained at the time that the land resumption cost was estimated based on the areas of land to be resumed. Members requested further details about the breakdown of the land resumption and clearance costs and the standard rates for calculating the land acquisition cost.

- Notes: 1. All the land to be resumed in the project 230DS is agricultural land within Compensation Zone "C". As published in the Gazette, the ex-gratia compensation rate for this zone is 50% of the Basic Rate for agricultural land. The land for 230DS was resumed in 2002, and the then Basic Rate for agricultural land was \$297 per sq. ft. Hence the ex-gratia compensation rate used for estimating the resumption cost of the 3 lots affected by the project 230DS was \$148.50 per sq. ft. (i.e. 50% of \$297 per sq. ft.).
 - 2. All the land to be resumed in the project 234DS is agricultural land within Compensation Zone "C". As published in the Gazette, the ex-gratia compensation rate for this zone is 50% of the Basic Rate for agricultural land. The land for 234DS will be resumed at the end of 2007, and the present Basic Rate for agricultural land is \$403 per sq. ft.
