I Election of Chairman

2. Ms Miriam LAU was nominated by Mr Abraham SHEK and the nomination was seconded by Mr Jeffrey LAM. Ms LAU accepted the nomination. There being no other nominations, Ms Miriam LAU was elected Chairman of the Subcommittee.

Action

3. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

Discussion on the proposed toll regime and the proposed toll levels

- 4. <u>The Administration</u> briefed members on the Tsing Sha Control Area (Tolls, Fees and Charges) Regulation (the Regulation). <u>Members</u> noted that under the Administration's proposal, the section between Sha Tin and Cheung Sha Wan would be tolled. In this regard, the Administration proposed to adopt a differential toll regime for the Tsing Sha Control Area (TSCA), with the toll for private cars/taxis set at \$12 and at corresponding levels for other types of vehicles, instead of a flat toll regime adopted by the Lion Rock Tunnel (\$8) and Shing Mun Tunnels (\$5).
- 5. Mr Andrew CHENG considered the Administration's above proposal inappropriate. He opined that the toll levels for TSCA should be set on a par with Lion Rock Tunnel. In response, the Administration explained that the proposed differential toll regime for TSCA was considered more reasonable and fair because it could reflect the different degrees of usage of road space and wear and tear caused by different types of vehicles. As to the proposed toll levels for TSCA, in determining the levels, the Administration had considered a basket of factors, including the user-pays principle, public acceptability and affordability, the diversion effect to ease the traffic of the alternative routes, and the strategic location of TSCA and tolls of alternative routes.
- 6. Noting the Administration's response, <u>Mr Abraham SHEK</u> opined that as the construction costs for different tunnels built over different times varied from each other, it would be more reasonable and acceptable for the Administration to take into account the actual costs of the capital employed for determining the toll levels for different tunnels. In the present case, having regard to the capital cost of the tolled section of TSCA at 5.8 billion, he considered the proposed toll levels appropriate. <u>Mr Andrew CHENG</u> was, however, not convinced, and said that he would consider moving amendments to the Regulation to the effect that a lower toll based on the flat toll regime be imposed in TSCA.

- 7. <u>The Subcommittee</u> then went through the Regulation section by section. In the course of examining the sections, <u>the Administration</u> agreed to take the following actions
 - (a) Examine further the proposal of using Octopus cards for payment of tunnel tolls with Octopus readers installed at the toll booths; and
 - (b) Rectify the minor clerical error in section 4(3) of the English text of the Regulation by replacing the word "of" after the word "demand" by "on" when the Regulation was next amended or by an order under section 98A(1) of the Interpretation and General Clauses

The way forward

8. <u>The Subcommittee</u> completed its deliberations on and was in general in support of the Regulation, and agreed to report its deliberations to the House Committee at the latter's meeting on 18 January 2008. <u>The Chairman</u> reminded members that a Member who wished to seek the President's permission to address the Council at the meeting on 30 January 2008 under Rule 21(5) of the Rules of Procedure on subsidiary legislation tabled in the Council should provide an advance copy of the intended address to the President.
