		(b) The cost recovery rates for the TES scheme were 82.7%, 83.3% and 83.1% in the year of 2004-2005, 2005-2006 and 2006-2007 respectively. Therefore, it was stated in the Administration's paper that the projected TES recovery rate for 2007-2008 was about 84%.	
		(c) The Administration had been very conscious of the need to control the operating costs of the sewage services. The total expenditure, comprising only operating and maintenance cost, had declined by 4% and unit treatment cost by 10% despite the increase in the volume of sewage treated.
