INTERPRETATION AND GENERAL CLAUSES ORDINANCE

RESOLUTION

Under section 34(2) of the Interpretation and General Clauses Ordinance (Cap.1)

Sewage Services (Trade Effluent Surcharge) (Amendment) Regulation 2008
