The Subcommittee deliberated (index of proceedings attached at **Annex**).

In the light of the comments made by the legal adviser to the Subcommittee that the scope of the Authority's power to impose conditions on renewal of the exemption under section 2 of Part 2 of the new Schedule 6 to the Food and Drugs (Composition and Labelling) Regulations (the Principal Regulations) should be made more specific, the Administration agreed to amend section 1 of Part 2 of the new Schedule 6 to the Principal Regulations.

3. In response to Mr Tommy CHEUNG's concern about the drafting of the phrase "renewal of the exemption in such manner as the Authority may determine" under section 2(2) of Part 2 of the new Schedule 6 to the Principal Regulations, the Administration explained that it referred to a prescribed form to be completed by the applicant. At the request of Mr CHEUNG, the Administration agreed to provide to the Subcommittee a performance pledge in respect of processing time for renewal of exemption applications.

*(Post-meeting note: the Administration's paper entitled "Application procedures in respect of prepackaged food with small sales volume" was issued to members vide LC Paper No. CB(2)1902/07-08(02) on 9 May 2008.)*

4. In response to Mr Tommy CHEUNG's query about the registration fees for new applications for exemption and for renewal of exemption under the small volume exemption scheme, the Administration explained that full-cost recovery fees of \$345 (i.e. new application) and \$335 (i.e. renewal of exemption) were calculated in strict accordance with the established formula approved by the Financial Services and the Treasury Bureau for calculating Government fees and charges. The staff cost incurred in processing applications was factored into the calculation of the full cost for the grant or renewal of exemption.

5. In response to the concern and suggestion raised by Ms Miriam LAU and Ms Audrey EU regarding the adequacy of appeal channels, the Administration explained that, as provided in section 3(4) of Part 2 of the new Schedule 6 to the Principal Regulations, the Authority should not revoke an exemption unless the Authority notified the grantee in writing of his intention to revoke the exemption and the grounds upon which the Authority proposed to revoke the exemption. Before revoking the exemption, the Authority was also required to permit the grantee to make representations to the Authority in writing within the period specified in the notice and to consider the representations, if any, made by the grantee. As provided in section 3(5) of Part 2 of the new Schedule 6 to the Principal Regulations, if the Authority revoked an exemption, the Authority should, as soon as practicable, notify the grantee in writing and specify in the notice the grounds for the revocation and

the date on which the revocation was to take effect. The Administration further explained that, in practice, the primary reason for refusing to grant an exemption under section 3(1) of Part 2 of the new Schedule 6 to the Principal Regulations would be that the annual sales volume of the product had exceeded 30 000 units in any one of the past two years. The Administration also pointed out that the decision of refusing to grant an application, revoking an exemption or refusing an application for renewal, was subject to judicial review. In the light of this, the Administration considered it unnecessary to specify in the Amendment Regulation that appeal against the decision of the Authority could be made to the Administrative Appeals Board.

6. In response to Mr Tommy CHEUNG's concern over the legal responsibility of food retailers selling the food products that were exempted under the small volume exemption scheme, the Administration explained that section 1(4) of Part 2 of the new Schedule 6 to the Principal Regulations provided that the Authority might impose such conditions as the Authority deemed fit. One of the conditions to be imposed on the importer or manufacturer to whom the exemption had been granted was that the importer or manufacturer concerned should inform the distributors and retailers that the exempted food products should be separately identified indicating the exemption status of the products when they were put on sale. They should also notify the Authority of any changes to their particulars, or to the names and addresses of the distributors/retailers during the validity period of the exemption.
